BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 11-334, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) The candidate and treasurer of the candidate 4 committee of each candidate whose name will appear on the ballot shall file preliminary, final, and supplemental reports as 5 follows: 7 (1)The filing dates for preliminary reports are: 8 Thirty calendar days before a primary, initial (A) 9 special, or initial nonpartisan election; 10 Ten calendar days before a primary, initial (B) 11 special, or initial nonpartisan election; [and] 12 (C) October 1 of the year of a general election; and 13 Ten calendar days before a general, subsequent (D) 14 special, or subsequent nonpartisan election; 15 provided that this preliminary report does not 16 need to be filed by a candidate who is **17** unsuccessful in a primary, initial special, or
