

## A BILL FOR AN ACT

RELATING TO ELECTIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that Act 136, Session

  Laws of Hawaii 2019, established that all elections statewide

  were to be conducted by mail beginning with the 2020 primary

  election. This bill allows election officials to establish
- 5 additional voter service centers, beyond the one designated for
- 6 each county, by permitting these additional voter service
- 7 centers to operate during different days and times. This
- $oldsymbol{8}$  addresses the needs of voters in certain areas where no voter
- 9 service center would have been established due to an inability
- $10\,$  to obtain a facility or personnel to support the operation of a
- 11 voter service center for ten business days or the hours
- 12 established for voter service centers statewide.
- SECTION 2. Section 11-109, Hawaii Revised Statutes, is
- 14 amended by amending subsections (a) and (b) to read as follows:
- 15 "(a) Voter service centers shall be established [ $\frac{at}{at}$  the
- 16 office of the clerk, and may be established at additional
- 17 locations within a county as may be designated by a clerk] by

2 voters. 3 (b) [Voter service centers] In each county, a voter 4 service center shall be open from the tenth business day 5 preceding the day of the election during regular business hours until the time provided in section 11-131 on the date of the 6 7 election and at the same times statewide. The clerks may operate additional voter service centers having varying days or 8 9 hours of operations to service the voters of particular areas 10 that otherwise could not support the operation of a voter 11 service center for ten business days or the same times 12 statewide. Any voter standing in line at a voter service center 13 at the closing time provided in section 11-131 on the date of 14 the election and having the intent of voting shall be allowed to 15 vote. A person eligible to vote but who is not registered to 16 vote and is standing in line at a voter service center at the 17 closing time provided in section 11-131 on the date of the 18 election shall be permitted to apply under section 11-15.2 to

register to vote and subsequently vote that election day. To
