

A BILL FOR AN ACT

RELATING TO TRAFFIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that unsafe driving
- 2 conditions may occur on two-lane roadways when the lead vehicle
- 3 is moving slowly, causing a back-up of vehicles behind the lead
- 4 vehicle, and traffic moving in the opposite direction makes
- 5 passing vehicles unsafe. This situation is frequently
- 6 encountered on Hana highway, between mile markers 00 and 34,
- 7 where visibility around turns is limited by natural contours of
- 8 the road.
- 9 Accordingly, the purpose of this Act is to promote traffic
- 10 safety on Hana highway by requiring drivers of lead vehicles on
- 11 the highway, between mile markers 00 and 34, to use turnouts and
- 12 allow vehicles to pass under certain circumstances.
- 13 SECTION 2. Section 291C-41, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- "[+] \$291C-41[+] Drive on right side of roadway;
- 16 exceptions. (a) Upon all roadways of sufficient width a

- 2 except as follows:
- 3 (1) When overtaking and passing another vehicle proceeding
- 4 in the same direction under the rules governing [such]
- 5 the movement;
- 6 (2) When an obstruction exists making it necessary to
- drive to the left of the center of the highway;
- 8 provided any person so doing shall yield the right-of-
- 9 way to all vehicles traveling in the proper direction
- upon the unobstructed portion of the highway within
- 11 [such] the distance [as to constitute] constituting an
- immediate hazard;
- 13 (3) Upon a roadway divided into three marked lanes for
- traffic under the rules applicable thereon; or
- 15 (4) Upon a roadway designated and signposted one-way
- 16 traffic.
- 17 (b) Upon all roadways any vehicle proceeding at less than
- 18 the normal speed of traffic at the time and place and under the
- 19 conditions then existing shall be driven in the right-hand lane
- 20 then available for traffic, or as close as practicable to the
- 21 right-hand curb or edge of the roadway, except when overtaking



- 1 and passing another vehicle proceeding in the same direction or
- 2 when preparing for a left turn at an intersection or into a
- 3 private road or driveway.
- 4 (c) Upon any roadway having four or more lanes for moving
- 5 traffic and providing for two-way movement of traffic, no
- 6 vehicle shall be driven to the left of the center line of the
- 7 roadway, except when authorized by official traffic-control
- 8 devices designating certain lanes to the left side of the center
- 9 of the roadway for use by traffic not otherwise permitted to use
- 10 [such] the lanes, or except as permitted under subsection
- 11 (a)(2). This subsection shall not be construed to prohibit the
- 12 crossing of the center line in making a left turn into or from
- 13 an alley, private road, or driveway.
- 14 (d) Upon Hana highway, between mile markers 00 and 34, if
- 15 passing is made unsafe due to traffic in the opposite direction
- 16 or other conditions, any vehicle proceeding upon the roadway,
- 17 behind which five or more vehicles are formed in line with no
- 18 more than thirty feet between each vehicle, shall turn off the
- 19 roadway at the nearest place designated as a turnout by signs
- 20 erected by the department of transportation, or wherever

sufficient area for a safe turnout exists, in order to permit
those other vehicles to proceed."

SECTION 3. New statutory material is underscored.

SECTION 4. This Act shall take effect upon its approval.
