## A BILL FOR AN ACT

RELATING TO THE COMMISSION ON SALARIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 26-56, Hawaii Revised Statutes, is SECTION 1. 2 amended by amending subsection (d) to read as follows: 3 "(d) The commission shall convene in the month of November 4 2006, and every six years thereafter. Not later than the 5 fortieth legislative day of the regular session of 2007, and 6 every six years thereafter, the commission shall submit a report 7 of its findings and its salary recommendations to the 8 legislature, through the governor. The commission may include 9 incremental increases that take effect [prior to] before the 10 convening of, and remain in effect for the next two fiscal years 11 after, the next [salary] commission.

12 [The recommended salaries submitted by the commission shall 13 become effective July 1 of the next fiscal year] The commission 14 that convenes in 2024, shall make salary recommendations through 15 fiscal year 2032-2033. The commission that convenes in 2030, 16 and each commission thereafter, shall make recommendations that take effect on July 1 of the first fiscal year of the fiscal

1 biennium after the immediately following fiscal biennium in 2 which the recommendation was made, unless the legislature 3 disapproves the recommended salaries submitted by the commission 4 through the adoption of a concurrent resolution, which shall be 5 approved by a simple majority of each house of the legislature, 6 [prior to] before adjournment sine die of the legislative 7 session in which the recommended salaries are submitted; 8 provided that any change in salary which becomes effective shall 9 not apply to the legislature to which the recommendation for the 10 change in salary was submitted.

11 The governor shall include the salary amounts recommended 12 by the commission and approved by the legislature for employees 13 of the executive branch in the executive budget. If the salary 14 amounts recommended by the commission are disapproved by the 15 legislature, the commission shall reconvene in the November next following the legislative disapproval to review the 16 17 legislature's reasons for disapproving its salary 18 recommendation. The commission may submit a report of its 19 findings and submit a new salary recommendation to the 20 legislature at the next regular session. The commission's

1 reconvening following a legislative disapproval shall not toll

2 the six-year cycle."

3 SECTION 2. Statutory material to be repealed is bracketed4 and stricken. New statutory material is underscored.
