### A BILL FOR AN ACT

RELATING TO FIREWORKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in the first three 2 weeks of December 2019, the Honolulu police department reported 3 more than five hundred complaints about fireworks. The legislature also finds that since 2011, fireworks-related 4 5 complaints have increased in all counties. The legislature 6 further finds that the proliferation of explosive contraband on 7 Oahu underscores a long-standing reality that authorities 8 largely have been unable to curtail the supply of aerials and 9 other black-market fireworks, according to the Honolulu Star-10 Advertiser. Furthermore, only a handful of cases involving the 11 illegal importation of fireworks or the unauthorized possession 12 of display fireworks have been publicly reported in recent 13 years.

14 To address the problem of illegal fireworks, Act 170,
15 Session Laws of Hawaii 2010, established the illegal fireworks
16 task force to develop strategies and make recommendations to the
17 legislature to address the illegal importation and use of

fireworks in the State. Among other recommendations, the task
 force recommended increasing random inspections for illegal
 fireworks by expanding inspection authority and focusing cargo
 inspections to make the inspections more manageable.

5 Subsequently, pursuant to Act 184, Session Laws of Hawaii 2019, the legislative reference bureau updated the findings and 6 7 recommendations of the Report of the Illegal Fireworks Task 8 Force to the Legislature for the Regular Session of 2011. The 2019 legislative reference bureau report, Blast From the Past: 9 An Update to the Report of the Illegal Fireworks Task Force to 10 the Legislature for the Regular Session of 2011, indicated that 11 12 the "majority of respondents to the [Legislative Reference] 13 Bureau's Survey appeared to agree that the issues and challenges presented by the Task Force in its 2011 report remain relevant 14 15 today."

16 The purpose of this Act is to address the illegal17 importation and use of fireworks in the State by:

18 (1) Establishing a shipping container inspection program
19 to randomly inspect shipping containers arriving in
20 the State for illegal fireworks and explosives,

1		including the use of explosive-sniffing dogs to

4	conduct the random inspection of shipping containers pursuant to
5	this section. The Hawaii national guard may be utilized to

7	(e) The department of public safety may request funding
8	from the federal government for homeland security and port
9	security measures and work with the military to secure other
10	funding sources for the purposes of the program.
11	(f) The department of public safety shall adopt rules in
12	accordance with chapter 91 for the purposes of this section.
13	<u>§266-B</u> Shipping container inspection program special fund.
14	(a) There is established in the state treasury the shipping
15	container inspection program special fund, into which shall be
16	deposited:
17	(1) Appropriations by the legislature to the special fund;
18	(2) Gifts, donations, and grants from public agencies and

1 costs expended to date, the estimated cost of operating the 2 program, and any proposed legislation. 3 SECTION 5. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$ or so 5 much thereof as may be necessary for fiscal year 2020-2021 to be deposited into the shipping container inspection program special 6 7 fund established pursuant to this Act. 8 SECTION 6. There is appropriated out of the shipping 9 container inspection program special fund the sum of \$ 10 or so much thereof as may be necessary for fiscal year 2020-2021 11 for costs to establish and administer the shipping container 12 inspection program, including the purchase, care, and handling 13 of at least two explosive-sniffing dogs. The sum appropriated shall be expended by the department of 14 public safety for the purposes of this Act. 15 16 SECTION 7. In codifying the new sections added by section 17 2 of this Act, the revisor of statutes shall substitute appropriate section numbers for the letters used in designating 18 19 the new sections in this Act. 20 SECTION 8. Statutory material to be repealed is bracketed 21 and stricken. New statutory material is underscored.

SECTION 9. This Act shall take effect on July 1, 2050;
 provided that sections 5 and 6 of this Act shall take effect on
 July 1, 2020.
