### A BILL FOR AN ACT

RELATING TO ENVIRONMENTAL PROTECTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that pollution from
- 2 cesspools is harming public health in the State. Currently,
- 3 there are roughly eighty-eight thousand cesspools that are
- 4 contaminating streams, oceans, ground water, drinking water, and
- 5 marine areas around the State. Additionally, the lack of
- 6 adequate sewer capacity has led to massive sewage discharges
- 7 into the ocean following heavy rains and has prevented the
- 8 development of new affordable housing in the urban core.
- 9 The legislature further finds that new waste management
- 10 solutions could greatly improve public health. Technologies
- 11 that are reaching a commercial scale for the first time include
- 12 solutions for individual homes, as well as multi-unit dwellings,
- 13 apartment buildings, and entire communities. Self-contained,
- 14 self-powered, and self-cleaning toilets can be used in homes
- 15 that do not have the capacity to connect to the existing sewer
- 16 infrastructure. Large waste management systems can remove
- 17 sewage from multi-unit dwellings and apartment buildings. At

- 1 the municipal scale, these technologies can effectively treat
- 2 sewage from entire communities for a small fraction of the cost
- 3 of existing technology now employed in Hawaii. Employing these
- 4 technologies can preserve local water quality and protect our
- 5 environment.
- 6 Act 132, Session Laws of Hawaii 2018, established the
- 7 cesspool conversion working group and tasked it with developing
- 8 a long-range, comprehensive plan for cesspool conversion
- 9 statewide and with considering methods by which the department
- 10 of health can ensure that cesspools are converted into more
- 11 environmentally-responsible waste treatment systems. The
- 12 legislature believes that funding a pilot project that reviews
- 13 available waste management technologies across different
- 14 topographies in Hawaii will assist the working group and the
- 15 department of health with the objectives of Act 132.
- 16 The purpose of this Act is to establish and fund a new
- 17 waste management solution pilot project to demonstrate new
- 18 toilet and sewage treatment technologies and to expedite
- 19 demonstration projects.

1	SECTION 2. (a) There is established a new waste	
2	management solution pilot project to be conducted by the	
3	department of health.	
4	(b)	The pilot project shall:
5	(1)	Review and demonstrate new toilet and sewage treatment
6		technologies at different scales and in different
7		locations across the State; and
8	(2)	Examine and implement a range of technologies, from
9		individual toilets to significantly larger multi-unit
10		systems, as well as examine options for community-
11		scale solutions as appropriate.
12	(c)	The department of health shall expedite demonstration
13	projects	conducted as part of the pilot project.
14	SECT	ION 3. There is appropriated out of the general
15	revenues	of the State of Hawaii the sum of \$ or so
16	much thereof as may be necessary for fiscal year 2020-2021 for	
17	the purpose of implementing the new waste management solution	
18	pilot project.	
19	The sum appropriated shall be expended by the department of	
20	health for the purposes of this Act.	

- 1 SECTION 4. The department of health shall submit a report
- 2 on the status of the new waste management solution pilot
- 3 project, including its findings, recommendations, and any
- 4 proposed legislation, to the legislature no later than twenty
- 5 days prior to the convening of the regular sessions of 2021 and
- **6** 2022.
- 7 SECTION 5. This Act shall take effect on July 1, 2020, and
- 8 shall be repealed on June 30, 2022.
