## A BILL FOR AN ACT

RELATING TO USE AND EQUIPMENT OF LESS THAN LETHAL FORCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that public safety officers, including state deputy sheriffs, provide invaluable 2 societal contributions by risking their lives each day in 3 service to Hawaii's residents. The legislature also finds that 4 5 public safety officers are in a position of public trust as the guardians and protectors of the State's communities. This role 6 requires extending respect and compassion to the people of the 7 State, while also holding individuals accountable for criminal 8 9 conduct. The legislature further finds that since 2015, the number 10 of fatal police shootings in Hawaii has more than doubled and 11 12 that it has risen from being less than one per cent of the national total to being two per cent in 2019. The State ranked 13 14 forty-fourth among the other states in 2015 in the number of fatal police shootings, but has climbed to ranking thirty-second 15 16 The legislature notes that the majority of these cases involved people who were not armed with a gun. 17

| 18 | officer with less-than-lethal weapons. For less than-lethal      |
| 19 | weapons, the department shall provide and require adequate       |
| 20 | annual training.   |

- 2 reviewed by the law enforcement standards board established
- 3 under section 139-2 and shall include use of force decision
- 4 making, crisis intervention, de-escalation techniques, and less
- 5 than lethal alternatives.
- 6 (d) The deputy director of the law enforcement division
- 7 shall be included and certified in all weapons training."
- 8 SECTION 3. The department of public safety shall report
- 9 its progress regarding compliance with the requirements of
- 10 section 353C- (a), Hawaii Revised Statutes, to the legislature
- 11 by November 1, 2021.
- 12 SECTION 4. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$200,000 or so much
- 14 thereof as may be necessary for fiscal year 2020-2021 for the
- 15 development and implementation of less than lethal use of force
- 16 training and related records management for the deputy sheriffs
- 17 of the department of public safety.
- 18 The sum appropriated shall be expended by the department of
- 19 public safety for the purposes of this Act.
- 20 SECTION 5. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$200,000 or so much

- 1 thereof as may be necessary for fiscal year 2020-2021 for the
- 2 purchase and maintenance of less than lethal equipment,
- 3 including weapons, for use by the deputy sheriffs of the
- 4 department of public safety certified in the less than lethal
- 5 use of force.
- 6 The sum appropriated shall be expended by the department of
- 7 public safety for the purposes of this Act.
- 8 SECTION 6. New statutory material is underscored.
- 9 SECTION 7. This Act shall take effect on July 1, 2020.
