

A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to create a county
- 2 education task force to establish a process for the transfer of
- 3 jurisdiction over all public schools, including all state public
- 4 education functions and funding, from the State to the county in
- 5 which the public school is located; provided that the county has
- 6 a population greater than five hundred thousand.
- 7 SECTION 2. (a) There is established a task force for the
- 8 orderly transfer of the functions of and funds for public
- 9 schools from the State to the county in which the public school
- 10 is located, provided that the county has a population greater
- 11 than five hundred thousand. The task force shall be attached to
- 12 the department of education for administrative purposes. The
- 13 governor shall convene the task force within thirty days after
- 14 the effective date of this Act.
- (b) The task force shall be composed of:
- 16 (1) The superintendent of education, who shall serve as
- 17 chair of the task force;

- 7 (f) The superintendent of education shall submit a report 8 to the legislature regarding task force activities, findings, 9 and recommendations, and any proposed legislation no later than
- 10 twenty days prior to the convening of the regular session of
- 11 2021. The legislative reference bureau shall assist the task
- 12 force in drafting proposed legislation to implement the
- 13 recommendations of the task force.
- 14 (g) For the purposes of this section:
- "County" means a county of the State with a population

 16 greater than five hundred thousand.
- "Public schools" shall have the same meaning as that term is defined in section 302A-101, Hawaii Revised Statutes.
- 19 (h) No member of the task force shall be made subject to 20 sections 84-13 and 84-17, Hawaii Revised Statutes, solely
