

A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE SECOND REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to

- 2 general obligation bonds in the sum of \$10,000,000 or so much
- 3 thereof as may be necessary and the same sum or so much thereof
- 4 as may be necessary is appropriated for fiscal year 2020-2021
- 5 for the purpose of capital improvement projects for the second
- 6 representative district, as follows:
- 7 1. Hilo high school track and field
- 8 Construction and equipment for
- 9 synthetic turf, rubberized track,
- bleachers, and equipment.
- 11 Construction \$7,500,000
- 12 Equipment \$500,000
- 13 Total funding \$8,000,000
- 14 The sum appropriated for this capital improvement project
- 15 shall be expended by the department of education.
- 16 2. Waiakea elementary school
