A BILL FOR AN ACT

RELATING TO THE MILITARY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the military's 2 presence in Hawaii has a significant impact on the State's 3 economy. According to the United States Department of Defense, 4 over forty-two thousand active duty military personnel are 5 assigned to Hawaii as of September 2019. The Hawaii department 6 of education estimates that Hawaii hosts over three hundred 7 thousand military personnel and their families. Although these 8 military personnel and their families engage in direct consumer 9 spending and pay taxes that contribute to Hawaii's economy, the 10 military's presence also impacts other aspects of Hawaii's 11 economy, such as education, housing, and natural resources.

According to the department of education, approximately fourteen thousand military dependents, which represent about eight per cent of the State's total student enrollment, attend public schools. The legislature further finds that military personnel stationed in Hawaii often require additional housing near military installments, while the military operations on

1 leased lands require environmental oversight by the State, which 2 uses state resources. Understanding the amount of revenue 3 generated by military spending in Hawaii and the extent of state 4 support afforded to military personnel will help the legislature 5 craft fiscal policy that safeguards the public trust and 6 advances the common good. 7 The purpose of this Act is to establish a task force to 8 evaluate the economic impact of the military's presence in 9 Hawaii. 10 SECTION 2. (a) There is established within the department 11 of business, economic development, and tourism for 12 administrative purposes a task force to study the economic 13 impact of the military's presence in Hawaii. The task force 14 shall consist of the following voting members: 15 (1)The director of budget and finance, or the director's 16 designee, who shall serve as the chairperson of the 17 task force; 18 (2) The director of business, economic development, and 19 tourism, or the director's designee; 20 (3) The chairperson of the board of land and natural 21 resources, or the chairperson's designee;

20	but shall	be reimbursed for necessary expenses incurred in the
21	performance	ce of their duties, including travel expenses.

3	(1)	Funding for public education, including the extent to
4		which federal impact aid reimbursements received by
5		the department of education fulfill the expenditures
6		required to meet the educational needs of federally
7		connected students;
8	(2)	Hawaii's housing supply, including the availability
9		and cost of housing and the cost of rent in
10		communities located near military installations;
11	(3)	Land use and environmental considerations; including
12		the cost to the State of monitoring, inspecting, and
13		restoring lands leased by the military to preserve
14		trust lands;
15	(4)	Consumer spending by military personnel and their
16		families; and
17	(5)	Any other issues deemed relevant by the task force.
18	(d)	The task force shall submit a report of its findings
19	and recommendations, including any proposed legislation, to the	
20	legislature no later than twenty days prior to the convening of	
21	the regular session of 2021.
