A BILL FOR AN ACT

RELATING TO SERVICE ANIMALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that programs operated by 2 organizations that provide professionally trained guide dogs, 3 services, and assistive aids for Hawaii's blind and visually 4 impaired community yield higher employment levels with less need 5 for lifetime support services for youth, and lead to greater 6 independence and mobility for adults and seniors, thus 7 minimizing the need for long term home and nursing care and 8 placing fewer burdens on family, friends, and the community.

9 The legislature further recognizes that only half of the 10 twenty-nine acre site in lower Halawa valley that constitutes 11 the State's animal quarantine facility has been slated for use 12 by the department of public safety as the location for the new Oahu community correctional center, and that an environmental 13 impact statement has already been prepared for the site, which 14 15 can allow the State to repurpose the remainder of this underutilized site for public benefit. The legislature finds 16 that there is an interest in developing an operational facility 17

in Hawaii for the professional training of guide dogs for 1 2 eventual service to blind and visually impaired residents, which 3 will reduce the dependence of Hawaii's residents on the 4 importation of such professionally trained guide dogs from 5 places like Australia. This reduction would be to the public 6 benefit. The legislature also finds that the State's existing 7 animal quarantine facility is currently being accessed and 8 utilized in a similar manner.

9 The purpose of this Act is to appropriate sufficient 10 funding to the department of agriculture for the planning and 11 design of a professional training facility for guide dogs and 12 other professionally trained service dogs on a designated 13 portion of the State's animal quarantine facility site.

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$300,000 or so much thereof as may be necessary for fiscal year 2020-2021 for the planning and design of a professional training facility for guide dogs and other professionally trained service dogs on a designated portion of the State's animal quarantine facility site in Halawa valley on the island of Oahu.
