RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 302D-3, Hawaii Revised Statutes, is	
2	amended b	y amending subsection (d) to read as follows:	
3	"(d)	Understanding that the role of the commission is to	
4	ensure a	long-term strategic vision for Hawaii's public charter	
5	schools,	each nominee to the commission shall meet the following	
6	minimum qualifications:		
7	(1)	Commitment to education. Each nominee's record should	
8		demonstrate a deep and abiding interest in education,	
9		and a dedication to the social, academic, and	
10		character development of young people through the	
11		administration of a high performing charter school	
12		system;	
13	(2)	Record of integrity, civic virtue, and high ethical	
14		standards. Each nominee shall demonstrate integrity,	
15		civic virtue, and high ethical standards and be	

willing to hold fellow commission members to the same;

1	(3)	Availability for constructive engagement. Each
2		nominee shall commit to being a conscientious and
3		attentive commission member; [and]
4	(4)	Knowledge of best practices. Each nominee shall have
5		an understanding of best practices in charter school
6		educational governance or shall be willing to be
7		trained in such [-]; and
8	(5)	Residence in Hawaii. Each nominee shall be a resident
9		of the State or shall be willing to relocate to the
10		State in order to foster availability, communication,
11		and community engagement and to lessen the economic
12		burden on the State."
13	SECT	ION 2. Section 302D-3, Hawaii Revised Statutes, is
14	amended b	y amending subsection (i) to read as follows:
15	"(i)	Commission members shall receive no compensation.
16	When commission duties require that a commission member take	
17	leave of the member's duties as a state employee, the	
18	appropria	te state department shall allow the commission member
19	to be pla	ced on administrative leave with pay and shall provide
20	substitut	es, when necessary, to fulfill that member's
21	departmen	tal duties. Members [ <del>shall</del> ] may be reimbursed for

- 2 of official commission business."
- 3 SECTION 3. Section 1 of this Act shall apply to nominees
- 4 nominated to the state public charter school commission on or
- 5 after the effective date of this Act.
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.

#### Report Title:

State Public Charter School Commission; Residency; Expenses

#### Description:

Amends the minimum qualifications for nominees to the State Public Charter School Commission to require residency in the State. Provides that commission members may be reimbursed for necessary and reasonable travel expenses incurred in the conduct of official commission business.
