A BILL FOR AN ACT

RELATING TO THE HAWAII STATE LESBIAN, GAY, BISEXUAL, TRANSGENDER, QUEER, PLUS COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii Revised Statutes is amended by 2 adding a new chapter to title 20 to be appropriately designated 3 and to read as follows: 4 "CHAPTER 5 HAWAII STATE LESBIAN, GAY, BISEXUAL, TRANSGENDER, QUEER, PLUS 6 COMMISSION 7 -1 Findings and purpose. The legislature finds that 8 there is a need to establish a body to improve the State's 9 interface with members of the lesbian, gay, bisexual, 10 transgender, queer, plus community, identify the short- and 11 long-range needs of its members, and ensure that there is an 12 effective means of researching, planning, and advocating for the 13 equity of this population in all aspects of state government. 14 The legislature further finds that establishing a program to 15 enable a better understanding of the risks and challenges,

including suicide, bullying, and ostracization, that the

- (6) Maintain contacts with appropriate federal, state, local, and international agencies concerned with the status of the lesbian, gay, bisexual, transgender, queer, plus community;
- (7) Cooperate and collaborate with national groups on the status of the lesbian, gay, bisexual, transgender, queer, plus community and arrange for participation by representatives of the State in White House conferences and other national conferences;
- (8) Administer funds allocated for the commission's work, including accepting, disbursing, and allocating funds that may become available from other governmental and private sources; provided that all funds shall be disbursed or allocated in compliance with any specific designation stated by the donor; provided further that in the absence of any specific designation, the funds shall be disbursed or allocated to projects related to any of the purposes of this chapter; and

- (9) Submit to the governor and legislature an annual
 report with recommendations.
- 3 § -7 County committees on lesbian, gay, bisexual,
- 4 transgender, queer, plus affairs; membership; organization. (a)
- 5 The mayor of each county may appoint a county committee. Each
- 6 county committee may be charged with:
- 7 (1) The duty and responsibility of developing information
 8 as the commission requires or as the county committee
 9 deems advisable concerning the status of the members
 10 of the lesbian, gay, bisexual, transgender, queer,
 11 plus community within the respective counties; and
- 12 (2) Any other appropriate duties and responsibilities as

 may be deemed necessary by the respective counties.
- 14 (b) The county committees may submit to the commission
 15 plans and proposals affecting the status of members of the
 16 lesbian, gay, bisexual, transgender, queer, plus community in
 17 the respective counties.
- (c) Each county committee may endeavor to secure the widest possible citizen participation in its efforts and, for this purpose, use existing public or private organizations.
- 21 Each county committee may include the county attorney or

1 corporation counsel and the county representative of the 2 commission as ex officio members. The other members may be 3 selected on the basis of their interest and knowledge in, and 4 their ability to make contributions to, the solution of problems 5 relating to the lesbian, gay, bisexual, transgender, queer, plus 6 community within the respective county and their knowledge of 7 local conditions. The chairperson of each county committee may 8 be elected annually from the nongovernmental members of the 9 committee. The terms of office of each member may be four 10 years. Each county committee may meet at least four times a 11 year. The members of the county committees may receive no 12 compensation for their services. The respective county 13 legislative bodies are authorized to make appropriations to meet 14 the necessary expenses of their respective committees." 15 SECTION 2. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ **17** much thereof as may be necessary for fiscal year 2020-2021 for 18 the Hawaii state lesbian, gay, bisexual, transgender, queer, 19 plus commission and to carry out the purposes of this Act. 20 The sum appropriated shall be expended by the department of
