A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established within the department
- 2 of human services a two-year mobile facilities pilot program
- 3 authorizing the department to purchase, staff, and operate
- 4 mobile facilities on department of education property to provide
- 5 services including laundry, oral hygiene, and food for any
- 6 homeless minor and any member of the homeless minor's family.
- 7 For purposes of this Act, "member of the minor's family"
- 8 means the minor's parent, stepparent, spouse, grandparent,
- 9 brother, sister, uncle, aunt, and any other person who is a
- 10 minor's legal or physical custodian or quardian, or who is
- 11 otherwise responsible for the minor's care.
- 12 (b) The mobile facilities pilot program shall provide, at
- 13 minimum, the following services to any homeless minor and any
- 14 member of the homeless minor's family:
- 15 (1) Clothes laundering equipment and supplies;
- 16 (2) Showering equipment and supplies;
- 17 (3) Oral hygiene equipment and supplies; and

- 1 (4) Food and drink.
- 2 (c) The department of human services shall implement the
- 3 mobile facilities pilot program no later than June 30, 2021, for
- 4 a duration of two years.
- 5 (d) The department of human services may procure mobile
- 6 facilities equipment and services for purposes of the mobile
- 7 facilities pilot program in accordance with chapter 103F, Hawaii
- 8 Revised Statutes.
- 9 (d) The department of human services shall submit to the
- 10 legislature a report of its progress, findings, and
- 11 recommendations relating to the mobile facilities pilot program,
- 12 including any proposed legislation, no later than twenty days
- 13 prior to the convening of the regular session of 2021.
- 14 SECTION 2. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2020-2021 for the
- 17 purchasing, staffing, and operation of mobile facilities on
- 18 department of education property to provide services including
- 19 laundry, showers, oral hygiene, and food for homeless children
- 20 in the State.

- 1 The sum appropriated shall be expended by the department of
- 2 human services for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2020.
