A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established within the department 2 of education a two-year mobile facilities pilot program to
- 3 provide services including laundry, oral hygiene, and food for
- 4 any homeless minor and any member of the homeless minor's
- 5 family. Under the pilot program, the department of education is
- 6 authorized to purchase, staff, and operate mobile facilities on
- 7 department of education property.
- 8 (b) The mobile facilities pilot program shall provide, at
- $oldsymbol{9}$ minimum, the following services to any homeless minor and any
- 10 member of the homeless minor's family:
- 11 (1) Clothes laundering equipment and supplies;
- 12 (2) Showering equipment and supplies;
- 13 (3) Oral hygiene equipment and supplies; and
- 14 (4) Food and drink.
- 15 (c) The department of education shall implement the mobile
- 16 facilities pilot program no later than June 30, 2021, for a
- 17 duration of two years.

- 1 (d) The department of education may procure mobile
- 2 facilities equipment and services for purposes of the mobile
- 3 facilities pilot program in accordance with chapter 103F, Hawaii
- 4 Revised Statutes.
- 5 (e) The department of education shall submit a progress
- 6 report of its findings and recommendations relating to the
- 7 mobile facilities pilot program, including any proposed
- 8 legislation, to the legislature no later than twenty days prior
- 9 to the convening of the regular session of 2021.
- (f) For purposes of this Act, "member of the homeless
- 11 minor's family" means the minor's parent, stepparent, spouse,
- 12 grandparent, brother, sister, uncle, aunt, and any other person
- 13 who is a minor's legal or physical custodian or guardian, or who
- 14 is otherwise responsible for the minor's care.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so
- 17 much thereof as may be necessary for fiscal year 2020-2021 for
- 18 the purchasing, staffing, and operation of mobile facilities on
- 19 department of education property to provide services for the
- 20 mobile facilities pilot program, including laundry, showers,

- 1 oral hygiene, and food for homeless minors and their family
- 2 members, in the State.
- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this Act.
- 5 SECTION 3. This Act shall take effect on December 31,
- 6 2059, and shall be repealed on June 30, 2022.
