A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that many persons who 2 have been diagnosed with fetal alcohol spectrum disorder face 3 profound challenges in navigating the State's present system of 4 care. Many persons with diagnoses on the spectrum cope with 5 lifelong physical, cognitive, or behavioral disabilities but age 6 out of eligibility for care services once they become adults. 7 Persons having fetal alcohol spectrum disorders or their parents 8 or careqivers may also find it difficult to access proactive 9 therapies that teach coping skills, improve functioning, and 10 foster community connections. The absence of these care 11 services can be devastating for those who face cognitive or 12 behavioral deficits due to their conditions; approximately fifty 13 per cent of persons diagnosed with fetal alcohol spectrum 14 disorder ultimately become involved with the criminal justice 15 system.

Accordingly, the purpose of this Act is to establish a taskforce to identify therapies and home- and community-based care
