

A BILL FOR AN ACT

RELATING TO AN ADVISORY REFERENDUM ON CANNABIS IN HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a true democracy in
- 2 Hawaii demands fuller participation by its citizens in matters
- 3 that affect all residents of the State. One avenue through
- 4 which voters may more fully participate is through an advisory
- 5 referendum.
- 6 The legislature finds that it is appropriate for the public
- 7 to make its views on the issue of whether the State should
- 8 legalize recreational cannabis known through a non-binding
- 9 referendum. Accordingly, the purpose of this Act is to require
- 10 a non-binding referendum regarding the question of whether to
- 11 allow the sale and use of recreational cannabis in the State.
- 12 SECTION 2. At the general election of 2020, there shall be
- 13 an advisory referendum on whether the electorate wishes the
- 14 State to legalize the sale and use of recreational cannabis in
- 15 the State. The chief election officer of the State shall submit
- 16 a proposal to the electorate with instructions in the form of
- 17 the following question:

- 1 "Shall the State of Hawaii allow the sale and use of
- 2 recreational cannabis in the State?"
- 3 The chief election officer shall publish a notice of the
- 4 advisory referendum question and descriptive information
- 5 regarding the sale and use of recreational cannabis in the State
- in a newspaper of general circulation in the State at least 6
- thirty days before the date of the advisory referendum. 7
- 8 notice of the advisory referendum shall also be available at all
- 9 public libraries in the State and the office of the county clerk
- 10 of each county.
- 11 The question shall be printed on the ballot and the
- 12 question shall have a designated space to mark YES or NO.
- chief election officer shall report the results of the advisory 13
- referendum to the legislature no less than twenty days prior to 14
- 15 the convening of the 2021 regular session.
- 16 SECTION 3. This Act shall take effect upon its approval.
