A BILL FOR AN ACT

RELATING TO HEALTH CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the cost of living 2 in Hawaii continues to rise, and the cost of health care 3 contributes to this high cost of living. The legislature 4 further finds that Vermont enacted legislation establishing a 5 single-payer health care system at the state level in 2011 but had abandoned the plan by 2014. Additionally, the California 6 7 Assembly attempted to pass legislation for universal health care 8 but was unable to because of the millions of taxpayer dollars 9 required for such a program. A different approach must be taken 10 to reduce the high costs of health care. 11 The legislature further finds that the human-induced global 12 climate crisis requires thoughtful but bold response on many fronts to make Hawaii communities resilient to the impacts of 13 14 climate change that threaten the very survivability of the

- 14 SECTION 2. (a) The department of health, in conjunction
- 15 with the department of human services and insurance
- 16 commissioner, shall conduct a study to determine the feasibility
- 17 of establishing an all-payer health care pilot program in a
- 18 county with a population greater than five hundred thousand.
- 19 This study shall focus on private health care coverage, medicare
- 20 coverage, and medicaid coverage. The study shall consider,
- 21 among other issues:

- 1 (1) Any potential legal challenges posed by the pilot
- 2 program; and
- 3 (2) The appropriateness of a medicaid section 1115 waiver.
- 4 (b) The department of health shall submit a report of its
- 5 findings and recommendations, including any proposed
- 6 legislation, to the legislature no later than twenty days prior
- 7 to the convening of the regular session of 2021.
- 8 SECTION 2. This Act shall take effect on July 1, 2050.
