# A BILL FOR AN ACT

RELATING TO VOTING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended 2 by adding a new section to part II to be appropriately 3 designated and to read as follows: 4 Automatic registration. (a) An application for 5 voter registration, including an affidavit, shall be a part of 6 the application for issuance of an identification card under 7 section 286-301 and the application for issuance of a driver's 8 license under section 286-109. Each application for voter 9 registration shall include a space to request a change of name 10 or address. 11 Applications for an identification card or driver's 12 license shall not be processed until the applicant completes the 13 portion of the application related to voter registration, 14 including change in name or address, or clearly indicates that 15 the applicant declines to register to vote. Unless an applicant 16 affirmatively declines to be registered to vote, the submission

of the application for the issuance of an identification card

- 2 under section 286-109 shall be deemed to authorize the examiner
- 3 of drivers to collect and transmit the information necessary to
- 4 register the applicant as a voter or make changes to the
- 5 applicant's voter registration information. The examiner of

- 7 to the clerk of the county in which the applicant resides,
- 8 election officials, and the online voter registration system
- 9 pursuant to subsection (d).
- 10 The examiner of drivers shall not transmit any information
- 11 necessary to register an applicant as a voter or change any
- 12 voter registration information, if that applicant affirmatively
- 13 declines to be registered to vote. The examiner of drivers
- 14 shall not electronically transmit any information, if that
- 15 applicant affirmatively declines for the information to be
- 16 transmitted.
- 17 (c) Upon receipt of the completed voter registration
- 18 application transmitted from the examiner of drivers, the clerk
- 19 shall review and either approve or reject the voter registration
- 20 application in accordance with this part; provided that approved
- 21 voter registration applications received from the examiner of

- 1 drivers pursuant to this section shall be treated as having a
- 2 valid signature for purposes of section 11-15(c) whether
- 3 transmitted electronically or by facsimile transmission. Upon
- 4 approval of the voter registration application, including a
- 5 request for change of voter registration information, the clerk
- 6 shall proceed to number the application and register the name of
- 7 the voter in the general county register as provided in section
- 8 11-14 or, as the case may be, make changes to the voter's
- 9 existing voter registration information.
- 10 (d) Databases maintained or operated by the counties or
- 11 the department of transportation containing driver's license or
- 12 identification card information, including any documents or
- 13 images, shall be directly accessible and provided electronically
- 14 to election officials and the online voter registration system
- 15 to allow for the timely processing of voter applications, ensure
- 16 the integrity of the voter registration polls, and for any other
- 17 voter registration or election purposes, as determined by the
- 18 director of transportation."
- 19 SECTION 2. Chapter 286, Hawaii Revised Statutes, is
- 20 amended by adding a new section to part VI to be appropriately
- 21 designated and to read as follows:

1	"§286-A Voter registration. (a) A qualified applicant						
2	for a new or renewed motor vehicle driver's license, provisional						
3	license, or instruction permit shall automatically be registered						
4	to vote with the clerk of the appropriate county upon completion						
5	of the license or permit application and the affidavit and						
6	application for voter registration as required in section 11-						
7	unless the qualified applicant affirmatively declines, on the						
8	application form, to be registered to vote. The qualified						
9	applicant may request on the same form that a change be made to						
10	the qualified applicant's name or address in the case of						
11	existing voter registration information.						
12	(b) Unless a qualified applicant affirmatively declines to						
13	be registered to vote, the submission of the affidavit and						
14	application for voter registration together with the license or						
15	permit application shall be deemed to authorize the examiner of						
16	drivers to collect and transmit the information necessary to						
17	register the qualified applicant as a voter or make changes to						
18	the qualified applicant's voter registration information, and						
19	the examiner of drivers shall electronically transmit the						
20	necessary information to the clerk of the county in which the

- 1 qualified applicant resides, election officials, and the online
- 2 voter registration system pursuant to section 11- (d).
- 3 The examiner of drivers shall not transmit any information
- 4 necessary to register a qualified applicant as a voter if that
- 5 qualified applicant affirmatively declines to be registered to
- 6 vote. The examiner of drivers shall not electronically transmit
- 7 any information, if that qualified applicant affirmatively
- 8 declines for the information to be transmitted.
- 9 (c) For the purposes of this section, "qualified

- 12 SECTION 3. Chapter 286, Hawaii Revised Statutes, is
- 13 amended by adding a new section to part XVI to be appropriately
- 14 designated and to read as follows:
- 15 "§286-B Voter registration. (a) A qualified applicant
- 16 for a new, renewal, or duplicate identification card shall
- 17 automatically be registered to vote with the clerk of the
- 18 appropriate county upon completion of an application for
- 19 identification card and the affidavit and application for voter
- 20 registration as required by section 11- unless the qualified
- 21 applicant affirmatively declines, on the application form, to be

- registered to vote. The qualified applicant may request on the

  same form that a change be made to the qualified applicant's

  name or address in the case of existing voter registration
- 4 information.
- 5 (b) Unless a qualified applicant affirmatively declines to
- 6 be registered to vote, the submission of the affidavit and
- 7 application for voter registration together with the application
- 8 for the identification card shall be deemed to authorize the
- 9 examiner of drivers to collect and transmit the information
- 10 necessary to register the qualified applicant as a voter or make
- 11 changes to the applicant's voter registration information, and
- 12 the examiner of drivers shall electronically transmit the
- 13 necessary information to the clerk of the county in which the
- 14 applicant resides, election officials, and the online voter
- 15 registration system pursuant to section 11- (d).
- 16 The examiner of drivers shall not transmit any information
- 17 necessary to register a qualified applicant as a voter if that
- 18 qualified applicant affirmatively declines to be registered to

6	The examinations shall be appropriate to the operation of the
7	category of motor vehicle for which the applicant seeks to be
8	licensed and shall be conducted as required by the director.
9	The examiner of drivers shall require every applicant to
10	comply with section 286-102.5.
11	The examiner of drivers may waive the actual demonstration
12	of ability to operate a motorcycle or motor scooter for any
13	person who furnishes evidence, to the satisfaction of the
14	examiner of drivers, that the person has completed the
15	motorcycle education course approved by the director in
16	accordance with section 431:10G-104.
17	[At the time of examination, an application for voter
18	registration by mail shall be made available to every applicant
19	for a driver's license.]

1 For the purposes of this section, the term "applicant" does 2 not include any person reactivating a license under section 3 286-107.5(a)." 4 SECTION 5. Section 286-109, Hawaii Revised Statutes, is 5 amended to read as follows: 6 "§286-109 General provision governing the issuance of 7 licenses. (a) Upon payment of the required fee and upon 8 demonstrating the ability to operate a certain category or 9 categories of motor vehicles to the satisfaction of the examiner 10 of drivers, an applicant for a driver's license shall be issued 11 a single license of a design approved by the director of 12 transportation upon which is made a notation of: 13 The person's full legal name, date of birth, gender (1) 14 designation, residence address, and license number; 15 (2) The category or categories of motor vehicles the 16 applicant may operate; **17** (3) Any restrictive provisions to which the license is 18 subject; 19 (4)Veteran status, if desired by the applicant; provided

that the notation shall be on the front of the license

  print that shall contrast with the other information

- 10 "Gender designation" includes the options of F, M, or X.
- "Veteran" means any person who served in any of the
  uniformed services of the United States, including veterans of
  the Korean conflict and persons who served in the armed forces
  of the Republic of Korea, who fought under the command of the
  United Nations led by the United States, during the Korean
  conflict and are currently United States citizens, and was
  discharged under conditions other than dishonorable.
- (b) The examiner of drivers shall not issue or renew any driver's license using the driver's social security number on the driver's license.

- 3 (d) An application for a driver's license shall include
- 4 the affidavit and voter registration application required under
- 5 section 11- ."
- 6 SECTION 6. Section 286-301, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "[+] §286-301[+] Issuance of identification card or
- 9 temporary card. (a) To obtain an identification card from the
- 10 examiner of drivers, an individual shall complete an application
- 11 pursuant to section 286-303.
- 12 (b) The examiner of drivers, upon receipt of the
- 13 application by any individual who is a resident or a temporary
- 14 resident of this State, shall issue an identification card to
- 15 that individual upon receipt of any appropriate fee established
- 16 pursuant to section 286-309.
- 17 (c) The identification card shall be similar in size,
- 18 shape, and design to a driver's license, but shall not entitle
- 19 the individual to whom it is issued to operate a motor vehicle.
- 20 (d) The issuance of an identification card pursuant to
- 21 this section shall not place upon the State of Hawaii or any

- 8 SECTION 7. Section 286-311, Hawaii Revised Statutes, is
- 9 amended by amending subsection (a) to read as follows:
- 10 "(a) All information and records acquired by the examiner
- 11 of drivers under this part shall be confidential [-]; provided
- 12 that the examiner may transmit voter registration information as
- 13 required under sections 286-A, 286-B, 286-109, and 286-301. All
- 14 information and records shall be maintained in an appropriate
- 15 form and in an appropriate office in the custody and under the
- 16 control of the examiner. The information shall be available
- 17 only to authorized individuals under such restrictions as the
- 18 director shall prescribe. The examiner may dispose of any
- 19 application or identification card, or information or record
- 20 relating to the application or identification card, which does
- 21 not include a social security number, without regard to chapter



- 1 94, whenever, in the examiner's discretion, retention of the
- 2 information or record is no longer required or practicable."
- 3 SECTION 8. The examiner of drivers in each county shall
- 4 cooperate with the office of elections to develop such forms,
- 5 applications, and affidavits necessary to effect the purposes of
- 6 this Act.
- 7 SECTION 9. In codifying the new sections added by sections
- 8 2 and 3 and referenced in section 7 of this Act, the revisor of
- 9 statutes shall substitute appropriate section numbers for the
- 10 letters used in designating the new sections in this Act.
- 11 SECTION 10. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 11. This Act shall take effect on July 1, 2050.

#### Report Title:

Automatic Voter Registration; Driver's License; Identification Card; Affirmative Opt-out

#### Description:

Requires that any person who is eligible to vote and applies for a motor vehicle driver's license or identification card to be automatically registered to vote unless the applicant affirmatively declines. Allows an applicant to affirmatively decline to have any of the applicant's information electronically transmitted. Authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver's license or identification card information to election officials and the online voter registration system. Effective 7/1/2050. (HD2)
