### A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that greenhouse gas 2 emissions are contributing to a climate crisis, with potentially 3 dire consequences for the State. Carbon sequestration, the act 4 of drawing carbon out of the air and into trees and soil, is an 5 important tool in reversing the climate crisis. Trees sequester 6 carbon through photosynthesis and soil carbon sequestration is 7 the process in which carbon dioxide is removed from the 8 atmosphere and stored in the soil carbon pool. This is the 9 combined result of increasing the amount of plant roots and 10 residues returned to the soil, decreased decomposition from soil 11 tillage, and decreased soil erosion. Growing more organic plant 12 food locally in Hawaii will provide greater food security and 13 reduce the use of fossil fuels to import plant food by air or 14 ship.

15 The legislature further finds that in order to assist in 16 reversing the levels of greenhouse gases, the agricultural 17 development and food security special fund should provide grants
