"Building-integrated photovoltaic" means any new 1 2 identifiable facility, equipment, apparatus, or the like, which generates electricity from solar energy and is integrated into 3 4 the structural elements of a building, such as photovoltaic 5 windows and skylights. "Nonmaterial additions and alterations" means an addition 6 7 to or alteration of the common elements or a unit that does not jeopardize the soundness or safety of the property, reduce the 8 9 value thereof, impair any easement, detract from the appearance 10 of the project, interfere with or deprive any nonconsenting 11 owner of the use or enjoyment of any part of property, or 12 directly affect any nonconsenting owner. "Passive solar skylights or windows" means any skylight or 13 14 window that regulates heating and cooling but does not generate electricity from solar energy. 15 "Solar energy device" means any new identifiable facility, 16 17 equipment, apparatus, or the like which makes use of solar 18 energy for heating, cooling, or reducing the use of other types 19 of energy dependent upon fossil fuel for its generation, 20 including but not limited to all types of building-applied photovoltaics and building-integrated photovoltaics; provided 21

1 that if the equipment sold cannot be used as a solar device 2 without its incorporation with other equipment, it shall be 3 installed in place and be ready to be made operational in order 4 to qualify as a "solar energy device"; provided further that 5 "solar energy device" shall not include passive solar skylights 6 or windows.

Report Title:

Condominiums; Declarations; Amendments; Board of Directors; Member Qualifications; Defamation; Limitation of Actions; Solar Energy Devices

Description:

Clarifies that all condominiums may amend their declarations by the vote or written consent of owners representing at least sixty-seven per cent of the common interest, unless amended by the unit owners to require a higher percentage. Clarifies the definition of "tenant" as it relates to those qualified to serve as a member of the board in the event a unit is owned by a corporation, partnership, or limited liability company. Limits defamation actions against an association, board of directors, association director, officer, attorney, or other association representative. Clarifies provisions concerning the installation of solar energy devices on common elements or limited common elements. (HD1)
