### A BILL FOR AN ACT

RELATING TO THE ACCESS HAWAII COMMITTEE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that state on-line
2	services and the means of conducting business over the Internet
3	have dramatically changed over the years. In order to better
4	serve the public and businesses, the State must be in alignment
5	with current practices of departments and agencies that now use
6	multiple internet services. The purpose of this Act is to give
7	departments more flexibility to deliver digital services to the
8	public; to better coordinate activities of multiple Internet
9	services used by the state; and to take full advantage of new
10	technologies and portal services available on the evolving
11	Internet.
12	SECTION 2. Chapter 27G, Hawaii Revised Statutes, is

There is established in the state treasury the access Hawaii committee 8 9 special fund, into which shall be deposited fees collected by 10 the office of enterprise technology services for the purpose of 11 supporting the access Hawaii committee.
