MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. This Act is recommended by the governor for

3 immediate passage in accordance with section 9 of article VII of

4 the Constitution of the State of Hawaii.

5 SECTION 2. There are appropriated from the sources of

6 funding indicated below to collective bargaining statewide (BUF

7 102) the following sums or so much thereof as may be necessary

8 to fund for fiscal biennium 2019-2021 all collective bargaining

9 cost items in the agreement negotiated with the exclusive

10 representative of collective bargaining unit (8):

- 1 SECTION 6. Salary increases and cost adjustments provided
- 2 in this Act for any officer or employee whose compensation is
- 3 paid, in whole or in part, from federal, special, or other funds
- 4 shall be paid wholly or proportionately, as the case may be,
- 5 from the respective funds.
- 6 SECTION 7. Funds appropriated or authorized by this Act
- 7 that are not expended or encumbered by June 30, 2021, shall
- 8 lapse as of that date.
- 9 SECTION 8. This Act shall take effect on January 1, 2050.
