#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In 2015, the United States Department of

### HB NO. 2337

#### JUSTIFICATION SHEET

- TITLE: A BILL FOR AN ACT RELATING TO CHRONICALLY HOMELESS.
- PURPOSE: To amend the definition of "chronically homeless" to align with the federal definition and to reduce confusion among providers, communities, and private partners.
- MEANS: Amend section 346-378(e), Hawaii Revised Statutes.
- JUSTIFICATION: The United States Department of Housing and Urban Development issued its final rule establishing the definition of "chronically homeless" in 24 C.F.R. § 578.3 (2017). The homeless services providers of the communities' continuum of care are required to use the definition in receipt of federal funds. Amending the State's definition of "chronically homeless" to better align with the federal agency's definition will allow more flexibility and consistency in the delivery of homeless services.

Impact on the public: Clarification will assist in improving the delivery and development of services for homeless individuals and families with a single definition funded by either federal or state agencies.
