Authorizes the Board of Land and Natural Resources to lease any existing state boating facility in part or in its entirety, and fast lands and submerged lands within any existing state boating facility, by public auction, request for proposals, or direct negotiation for private development, management, and operation. Clarifies that legislative approval is not required to award a lease. Repeals fast lands and submerged lands lease authorization for Ala Wai Boat Harbor under section 200-2.6, Hawaii Revised Statutes.

DEPARTMENT: Land and Natural Resources

TITLE: A BILL FOR AN ACT RELATING TO STATE BOATING

FACILITIES.

PURPOSE: To authorize the Board of Land and Natural

Resources (Board) to lease any existing state boating facility in part or in its entirety, and fast lands and submerged lands within any existing state boating facility, by public auction, request for proposals, or direct negotiation for private development, management, and operation; to clarify that legislative approval is not required to award a lease; and to repeal fast lands and submerged lands lease authorization for Ala Wai Boat Harbor under section 200-2.6,

Hawaii Revised Statutes (HRS).

MEANS: Amend section 200-2.5(a) and repeal section

200-2.6, HRS.

operation.

JUSTIFICATION: The Department is exploring potential

public-private partnerships for management of state small boat harbors and boating facilities as a way to preserve coastal resources and provide a method of ensuring timely maintenance and repairs to small boat harbors and boating facilities. This bill would authorize the Board to lease any existing state boating facility in part or in its entirety, and fast lands and submerged lands within any existing state boating facility, by public auction, request for proposals, or direct negotiation for private development, management, and

Currently, section 200-2.5(a), HRS, authorizes the Board to lease "fast lands and submerged lands within an existing state boating facility" by public auction, a request for proposals, or by direct negotiation pursuant to section 171-59, HRS, and chapter 190D, HRS, for private

development, management, and operation, provided that any lease of fast lands or submerged lands pursuant to a request for proposals shall be subject to section 200-2.6, HRS, regardless to which state boating facility the fast or submerged lands are attached. In turn, however, section 200-2.6, HRS, only addresses leases of the Ala Wai Boat Harbor. The reference to section 200-2.6, HRS, within section 200-2.5(a), HRS, is ambiguous and confusing. proposal seeks to remove the reference to section 200-2.6, HRS, within section 200-2.5, HRS, to not limit the fast lands and submerged lands of the Ala Wai Boat Harbor that may be leased.

Impact on the public: This bill would provide the Department with more flexibility and options to upgrade and improve state boating facilities to the benefit of boaters.

Impact on the department and other agencies: This bill would provide the Department with more flexibility and options in managing, maintaining, and improving state boating facilities.
