# A BILL FOR AN ACT

RELATING TO RENTAL MOTOR VEHICLE MARKETPLACE FACILITATORS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 251, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§251- Rental motor vehicle marketplace facilitators.
5	(a) A rental motor vehicle marketplace facilitator, as defined
6	under section 251-1, shall be deemed the rental motor vehicle
7	lessor for purposes of section 251-2.
8	(b) Any person other than a rental motor vehicle
9	marketplace facilitator who provides a forum, whether physical
10	or electronic, in which rental motor vehicle lessors list or
11	advertise rental motor vehicles for lease and takes or processes
12	<pre>lease orders shall:</pre>
13	(1) Post a conspicuous notice on its forum that informs
14	rental motor vehicle lessors intending to lease rental
15	motor vehicles in this State that the rental motor
16	vehicle lessor is required to pay the rental motor

1		vehicle and tour vehicle surcharge tax under section		
2	251-2; and			
3	(2)	(2) No later than the twentieth day of the fourth month		
4		following the close of the taxable year, submit a		
5		report to the department that includes, with respect		
6		to each rental motor vehicle lessor, the following:		
7		(A) The rental motor vehicle lessor's name, billing		
8		address, and mailing address;		
9		(B) The address in this State at which the rental		
10		motor vehicle was delivered to the lessee; and		
11		(C) The aggregate dollar amount of the lessee's		
12		<u>leases from the lessor;</u>		
13	provided	that the person, in lieu of complying with the notice		
14	and repor	ting requirements in this subsection, may elect to be		
15	deemed th	e rental motor vehicle lessor as provided in subsection		
16	<u>(a).</u>			
17	(c)	Any person who fails to comply with subsection (b) and		
18	has not e	lected to be deemed the rental motor vehicle lessor,		
19	unless it	is shown that the failure is due to reasonable cause		
20	and not d	ue to neglect, shall be assessed a penalty of \$1,000 if		
21	the failu	re is for not more than one month, with an additional

1	\$1,000 for each additional month or fraction thereof during		
2	which the failure continues, not to exceed \$12,000 in the		
3	aggregate.		
4	(d) Notwithstanding subsections (a) and (b), this section		
5	shall not apply to transactions involving rental motor vehicles		
6	leased by a lessor, who in any single month in the past twelve		
7	months, has leased one or more rental motor vehicles for thirty		
8	or more days or portions of days in the aggregate. For purposes		
9	of this subsection, the term "lessor" does not include a rental		
10	motor vehicle marketplace facilitator."		
11	SECTION 2. Section 251-1, Hawaii Revised Statutes, is		
12	amended by adding a new definition to be appropriately inserted		
13	and to read as follows:		
14	""Rental motor vehicle marketplace facilitator" means any		
15	person who leases or assists in the lease of rental motor		
16	vehicles on behalf of another rental motor vehicle lessor by:		
17	(1) Providing a forum, whether physical or electronic, in		
18	which lessors list or advertise the lease of rental		
19	motor vehicles; and

1	(2) Collec	ting payment from the rental motor vehicle
2	lessee	, either directly or indirectly through an
3	agreem	ent with a third party."
4	SECTION 3.	New statutory material is underscored.
5	SECTION 4.	This Act shall take effect on July 1, 2050.
