A BILL FOR AN ACT

RELATING TO THE ESTABLISHMENT OF AN ECOSYSTEM RESTORATION COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as part of the green 2 new deal-Hawaii initiative, that the State has an interest in 3 maintaining and restoring its lands so that they are in a safe 4 and healthy condition for the benefit of all who reside or come 5 to Hawaii. The legislature finds that remediation and 6 restoration of contaminated or otherwise hazardous lands is a 7 priority.

The legislature finds that the human-induced global climate 8 9 crisis requires a thoughtful but bold response on many fronts to 10 make Hawaii communities resilient to the impacts of climate change that threaten the very survivability of these fragile 11 islands. Lest Hawaii lose its leadership position in meeting 12 13 the future of labor, justice and equity, the legislature embraces aloha 'aina as a green new deal to decarbonize Hawaii's 14 systems of food, energy, and transportation, and to sequester 15 16 carbon through systems of agriculture, waste management and

ecosystem restoration. This solid foundation finds synergies
with expanded access to health, housing and education,
multiplying good jobs and ensuring justice and equity for
Hawaii's citizens. The following measure represents a forward
step in mitigating and adapting Hawaii to inevitable change.

Many properties on the islands of Hawaii are under federal 6 7 ownership or control and are being, or have been, used as 8 military facilities. The legislature finds that such use has 9 resulted in contamination to the water and soil on and adjacent to many of these properties, or that there exist more immediate 10 11 hazards, such as from the presence of unexploded ordnance. 12 Immediate action in the form of an "ecosystem restoration 13 commission" is needed in anticipation of the upcoming expiration 14 of land leases between the State and the United States federal 15 government.

16 The purpose of this Act is to establish an ecosystem 17 restoration commission that will be tasked with overseeing the 18 return of these lands to the State.

19 SECTION 2. Chapter 171, Hawaii Revised Statutes, is 20 amended by adding a new section to be appropriately designated 21 and to read as follows:

14		with relevant subject matter jurisdiction encompassing
15		environmental protection and restoration as determined
16		by each house of the legislature;
17	(4)	One representative from each of the four counties who
18		shall be selected by the mayors of that
19		representative's county;
20	(5)	At least one representative from an organization with
21		a mission statement or purpose dedicated to the

1		remediation and prevention of military debris and site
2		contamination or degradation;
3	(6)	At least one representative from a Hawaiian
4		organization with a mission statement or purpose of
5		preserving native Hawaiian traditional and cultural
6		practices, and preventing the desecration of the
7		environment;
8	(7)	A representative from the United States military; and
9	(8)	A representative from the United States Environmental
10		Protection Agency.
11	(b)	The ecosystem restoration commission shall:
12	(1)	Create and maintain an inventory of all lands in the
13		State where the federal government claims ownership or
14		control, including a database of relevant leases and
15		their expiration dates;
16	(2)	Identify and evaluate any and all environmental damage
17		to and any required remediation efforts for the
18		inventoried lands;
19	(3)	Identify which lands are appropriate for continued
20		set-aside to the United States government;

1	(4)	Negotiate with the appropriate federal agencies for
2		the return of ownership and control and the
3		environmental remediation of parcels of property still
4		under the ownership or control of the federal
5		government;
6	(5)	Ensure that administrative control over all property
7		and property interests transferred from the federal
8		government to the State shall be given to an
9		appropriate state, county, or other entity; and
10	(6)	Make recommendations for future use and environmental
11		remediation of each property.
12	(C)	The ecosystem restoration commission shall submit its
13	report on	all activities and findings pursuant to subsection (b)
14	to the go	vernor and legislature. The report shall be submitted
15	no later	than twenty days prior to the convening of each regular
16	session.	
17 ,	(d)	The ecosystem restoration commission shall initiate
18	negotiati	ons, pursuant to paragraph (b)(4), with a set of
19	requests	and demands made to a representative of the United
20	<u>States mi</u>	litary who is charged with negotiations on behalf of
21	the Unite	d States. The ecosystem restoration commission shall

1	submit to the representative these requests and demands no later
2	than January 1, 2021. Thereafter, the ecosystem restoration
3	commission shall initiate a new round of negotiations, with an
4	updated set of requests and demands, each year for ten years."
5	SECTION 3. New statutory material is underscored.
6	SECTION 4. This Act shall take effect on July 1, 2020, and
7	shall be repealed on June 30, 2031.
