### A BILL FOR AN ACT

RELATING TO GRANTS FOR LOCAL RECYCLING FACILITIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has grappled
- 2 with solutions to deal with municipal waste for decades.
- 3 Landfill capacity is rapidly decreasing, even after creating
- 4 mitigation measures like exportation and incineration.
- 5 Currently, the vast majority of recyclable materials are
- 6 recycled outside the State. Landfill diversion has global
- 7 environmental benefits, including reducing the need to extract
- 8 raw materials from mines, such as aluminum, and decreasing the
- 9 amount of methane gas released into the atmosphere as waste
- 10 decomposes. Landfills are the third largest source of methane
- 11 emissions in the United States behind industry and agricultural
- 12 sources. According to the United States Environmental
- 13 Protection Agency, methane is the second most prevalent
- 14 greenhouse gas emitted in the United States from human
- 15 activities, which has a significant impact on climate change.
- 16 The legislature further finds that an investment in local
- 17 recycling facilities is immediately necessary to the human

1	impact on Hawaii's natural environment and mitigate the effects		
2	of the climate crisis.		
3	The purpose of this Act is to incentivize the development		
4	of new recycling, bioconversion, or composting businesses within		
5	the State of Hawaii.		
6	SECTION 2. Section 342G-14, Hawaii Revised Statutes, is		
7	amended to read as follows:		
8	"[+]	§342G-14[+] Powers and duties of the office of solid	
9	waste management. The office shall:		
10	(1)	Promote the development of coordinated statewide solid	
11		waste management;	
12	(2)	Identify and monitor environmental and public health	
13		issues relating to solid waste management;	
14	(3)	Promote source reduction, recycling, and	
15		bioconversion, including home composting, through the	
16		provision of a comprehensive, innovative, and	
17		effective statewide public education and awareness	
18		program concerning the value of source reduction and	
19		recycling, and the way the public can participate in	
20		these areas;	

1	(4)	Comply with the federal Resource Conservation and
2		Recovery Act of 1976 (42 United States Code section
3		6901 et seq.) and any other federal law heretofore or
4		hereafter enacted affecting solid waste;
5	(5)	Seek compliance with sections 226-18, 226-52, and 226-
6		103;
7	(6)	Assess the feasibility of employing disposal fees,
8		including fees at the point of introduction or sale of
9		any product that would require eventual disposition as
10		solid waste, as possible funding sources for waste
11		management activities;
12	(7)	Coordinate with the department of land and natural
13		resources to incorporate solid waste management and
14		processing concerns in the department of land and
15		natural resources' land use planning and development
16		efforts;
17	(8)	Coordinate the bioconversion efforts of appropriate
18		agency and county activities, including the provision
19		of technical assistance and the evaluation of
20		bioconversion programs;

1	(9)	Provide waste evaluation services and assistance in
2		developing paper recycling and other materials
3		programs to both the public and private sector, where
4		feasible;
5	(10)	Promote the use of enterprise zones in each county to
6		support source reduction, recycling, and
7		bioconversion-type businesses;
8	(11)	Establish a recycling facility grant program to
9		incentivize reduction, recycling, bioconversion, or
10		composting businesses in the State;
11	[ <del>(11)</del> ]	(12) Create and maintain a database to assess the
12		composition of the State's waste stream. If feasible
13		this database shall contain the information necessary
14		to generate the office's annual report;
15	[ <del>(12)</del> ]	(13) Identify and apply for appropriate federal funds
16		to support the programs and activities authorized by
17		this chapter; and
18	[ <del>(13)</del> ]	(14) Cooperate with appropriate federal, state, and
19		county agencies in carrying out the office's
20		responsibilities under this chapter."

- 1 SECTION 3. (a) There is established in the office of
- 2 solid waste management within the department of health a
- 3 recycling facility grant program to be administered by the
- 4 department. The department shall issue grants to recycling
- 5 facility operators to assist them in offsetting the costs of
- 6 operations within the State.
- 7 (b) Applications for the grants shall be submitted on a
- 8 form furnished by the department and shall be filed with any
- 9 accompanying documentation as may be required by the office.
- 10 (c) Grant program funds shall be disbursed from the
- 11 environmental management special fund established under section
- 12 342G-63, Hawaii Revised Statutes, upon approval by the
- 13 department, to the recycling facility operator for up to
- **14** \$750,000.
- 15 (d) The department shall adopt rules pursuant to chapter
- 16 91, Hawaii Revised Statutes, necessary for carrying out the
- 17 purposes of this section.
- (e) For the purposes of this section:
- 19 "Department" means the department of health.
- 20 "Office" means the office of solid waste management.



1 "Recycling" means the collection, separation, recovery, and 2 sale or reuse of secondary resources that would otherwise be 3 disposed of as municipal solid waste, and is an integral part of 4 a manufacturing process aimed at producing a marketable product 5 made of postconsumer material. 6 SECTION 4. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so 8 much thereof as may be necessary for fiscal year 2020-2021 for 9 the implementation of the recycling facility grant program 10 pursuant to this Act. 11 The sum appropriated shall be expended by the office of 12 solid waste management for the purposes of this Act. 13 SECTION 5. Statutory material to be repealed is bracketed

14 and stricken. New statutory material is underscored.
