## A BILL FOR AN ACT

RELATING TO CRITICAL ELECTRICAL INFRASTRUCTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the security and
- 2 resilience of Hawaii's critical electrical infrastructure are
- 3 fundamental to the health and welfare of the State's residents,
- 4 visitors, and employees and to the national defense of the
- 5 country. The legislature acknowledges that modern society
- 6 functions because of safe, affordable, and reliable electrical
- 7 power. However, existing trespassing laws do not provide a
- 8 proportionate level of protection for such a key resource.
- 9 The purpose of this Act is to protect the public and
- 10 critical electrical utlities by establishing the offense of
- 11 trespassing on critical electrical infrastructure.
- 12 SECTION 2. Chapter 708, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "§708- Criminal trespass on critical electrical
- 16 infrastructure. (1) A person commits the offense of criminal
- 17 trespass on critical electrical infrastructure when:

1	<u>(a)</u>	The person intentionally enters or remains unlawfully
2		on property of a critical electrical infrastructure
3		with intent to commit therein a crime against a person
4		or against property rights, and the property is fenced
5		or enclosed in a manner designed to exclude intruders
6		with posted warning signs; or
7	<u>(b)</u>	The person recklessly disregards a risk that the
8		property belongs to a critical electrical
9		infrastructure company.
10	(2)	An act occurs in the course of committing the offense
11	if it occ	urs in effecting entry or while on the property or in
12	immediate	flight therefrom.
13	(3)	Trespassing on a critical electrical infrastructure is
14	a class C	felony."
15	SECTION 3. Section 708-800, Hawaii Revised Statutes, is	
16	amended by adding a new definition to be appropriately inserted	
17	as to read as follows:	
18	""Critical electrical infrastructure" means areas integral	
19	to the operation or function of:	
20	(1)	A power plant;

1	(2)	A power generation facility used specifically during
2		times of high demand;
3	(3)	An electric transmission facility;
4	(4)	An electric station or substation; or
5	(5)	Any other facility used to support the generation,
6		transmission, or distribution of electricity.
7	"Critical	electrical infrastructure" does not include support
8	offices,	electric transmission land, or right-of-way that is not
9	completel	y enclosed and maintained by the electric utility."
10	SECTION 4. This Act does not affect rights and duties tha	
11	matured, penalties that were incurred, and proceedings that wer	
12	begun bef	ore its effective date.
13	SECT	ION 5. New statutory material is underscored.
14	SECT	ION 6. This Act shall take effect on July 1, 2050.
