

A BILL FOR AN ACT

RELATING TO EMERGENCY WORKERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 707-700, Hawaii Revised Statutes, is 2 amended by amending the definition of "emergency worker" to read 3 as follows: 4 "Emergency worker" means any: Law enforcement officer, including any police officer, 5 (1)6 public safety officer, parole or probation officer, or 7 any other officer of any county, state, federal, or 8 military agency authorized to exercise law enforcement 9 or police powers; 10 (2) Firefighter, emergency medical services personnel, 11 emergency medical technician, ambulance crewmember, or 12 any other emergency response personnel; 13 (3) Member of the Hawaii National Guard on any duty or 14 service done under or in pursuance of an order or call 15 of the governor or the President of the United States 16 or any proper authority;

2		Marine Corps, or Coast Guard on any duty or service
3		performed under or in pursuance of an order or call of

6	(5)	Member of the National Guard from any other state

8	(6)	Person engaged in emergency management functions as
9		authorized by the director of Hawaii emergency
10		management or the administrator or director of the
11		county emergency management agency or as otherwise
12		authorized under chapter 127A[-]; or
13	(7)	Telecommunications dispatcher, including any call-
14		taker, police, fire, or emergency medical dispatcher,
15		or any combination of these; emergency dispatcher; or
16		any other telecommunications dispatch personnel who,
17		while operating a 9-1-1 automated terminal, utilizes
18		multiple robust lifesaving procedures and technologies
19		to obtain critical information from the caller,
20		analyzes the information given and, from specialized
21		mapping systems, sends the appropriate and closest

1	available emergency unit and communicates the best
2	course of action for the caller to take prior to the
3	arrival of the field first responder."
