#### A BILL FOR AN ACT

RELATING TO A HAWAII GREEN NEW DEAL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that climate change is
- real and is the overriding challenge of the twenty-first 2
- 3 century. Thus, climate change is one of the priority issues of
- 4 the legislature. Climate change poses immediate and long-term
- 5 threats to the State's economy, sustainability, security, and
- 6 way of life. Hawaii has a tradition of sustainable leadership,
- 7 having prioritized policies regarding greenhouse gas emission
- 8 reduction, conservation, economic resilience, environmental
- 9 protection, and the use of alternative renewable energy.
- 10 legislature has passed numerous measures over the last decade to
- 11 address climate change.
- 12 The legislature further finds that the human-induced global
- 13 climate crisis requires bold, thoughtful responses on many
- 14 fronts to ensure that resilient communities survive and thrive
- 15 on the fragile islands of Hawaii. To maintain Hawaii's
- 16 leadership in creating the future of labor, justice, and equity,
- **17** the legislature finds that we must embrace aloha aina as the



- 1 core organizing principal of our green new deal. We must
- 2 urgently decarbonize Hawaii's systems of food, energy, and
- 3 transportation. We must urgently sequester carbon throughout
- 4 our systems of agriculture, waste management, and ecosystem
- 5 restoration. Upon this solid foundation we will find synergies
- 6 that expand access to health, housing, and education; create
- 7 gratifying, well-paying jobs; and ensure justice and equity for
- 8 Hawaii's citizens. This Act is a vital step forward to enable
- 9 Hawaii to adapt to the inevitable changes that will accompany
- 10 the climate crisis, by proactively mitigating its most
- 11 deleterious impacts.
- 12 In July 2014, the State launched the Aloha+ challenge: He
- 13 Nohona 'Ae'oia, A Culture of Sustainability, a statewide
- 14 commitment to sustainability, with the leadership of the
- 15 governor, four county mayors, office of Hawaiian affairs,
- 16 legislature, and Hawaii green growth public-private partners
- 17 across the State. The Aloha+ challenge builds on Hawaii's
- 18 history of systems thinking, Hawaiian culture and values, and
- 19 successful track record on sustainability to outline six
- 20 ambitious goals to be achieved by 2030.

1 The legislature also finds that on December 12, 2015, one hundred ninety-five countries at the twenty-first Conference of 2 3 the Parties of the United Nations Framework Convention on Climate Change adopted an agreement addressing greenhouse gas 4 emissions mitigation, adaptation, and finance starting in the 5 6 year 2020, known as the Paris Agreement. The Paris Agreement was adopted on November 4, 2016, and is the largest concerted 7 8 global effort to combat climate change to date. The legislature 9 passed Act 32, Session Laws of Hawaii 2017, to document the 10 State of Hawaii's commitment to combat climate change by systematically reducing greenhouse gas emissions and improving 11 12 our resiliency to climate change aligned with the principles and 13 contributing to the goals set by the Paris Agreement. At the global level, the United Nations sustainable 14 15 development goals and Paris Climate Agreement have been adopted 16 to guide global efforts. In 2012, the United Nations Conference **17** on Sustainable Development created the sustainable development 18 goals, otherwise known as the 2030 Agenda for Sustainable 19 Development, in Rio de Janeiro. The goals came into effect in 20 2015, and are a universal call to action to end poverty, protect 21 the planet, and ensure that all people enjoy peace and

- 1 prosperity. Dealing with the threat of climate change impacts
- 2 how people manage the world's fragile natural resources.
- 3 In 2018, Governor David Ige issued Executive Order No.
- 4 18-06 that directed all state agencies to implement practices to
- 5 assist the State in achieving the United Nations sustainable
- 6 development goals. Additionally, four counties have expressed
- 7 support for the sustainable development goals.
- 8 In order for Hawaii to continue to serve as a leader for
- 9 the rest of the world in setting policies on sustainability, it
- 10 is essential that the State demonstrate its full commitment to
- 11 its own polices and goals, as well as the goals set on the
- 12 international stage at United Nations conferences and summits on
- 13 sustainability.
- 14 The purpose of this Act is to direct the state
- 15 sustainability coordinator and office of planning to conduct a
- 16 study on implementing a "Green New Deal for Hawaii".
- 17 SECTION 2. (a) The State's sustainability coordinator of
- 18 the office of planning shall complete a comprehensive study on
- 19 implementing a green new deal for Hawaii.
- 20 (b) The green new deal study shall:

1	(1)	Identify federal and international initiatives and
2		policies for a green new deal, including any related
3		costs and savings;

- 4 (2) Comprehensively review the State's economic

  5 resilience, efforts in environmental protection and

  6 growth, and protections for Hawaii's social and

  7 cultural equity;
- 8 (3) Determine and make detailed findings as to how the
  9 State can move forward to cost effectively take
  10 advantage of identified opportunities, including any
  11 related costs and savings to implement a Hawaii-based
  12 green new deal strategy; and
- 13 (4) Identify any legal and regulatory changes necessary to
  14 implement the findings determined pursuant to
  15 paragraph (3).
- (c) The state sustainability coordinator in the office of planning shall submit a progress report and a final report of its findings and recommendations, including any proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2021, and regular session of 2022, respectively.

- 2 revenues of the State of Hawaii the sum of \$600,000 or so much
- 3 thereof as may be necessary for fiscal year 2020-2021 for the
- 4 state sustainability coordinator and office of planning to
- 5 complete a comprehensive study on implementing a green new deal
- 6 for Hawaii.
- 7 The sum appropriated shall be expended by the office of
- 8 planning for the purposes of this Act.
- 9 SECTION 4. This Act shall take effect on July 1, 2020.
