# A BILL FOR AN ACT

RELATING TO THE STATE BUDGET.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. This Act shall be known and may be cited as the  
3 Supplemental Appropriations Act of 2020.

4 PART II

5 SECTION 2. This part amends Act 5, Session Laws of Hawaii  
6 2019, and other appropriations and authorizations effective  
7 during fiscal biennium 2019-2021.

8 SECTION 3. Part II of Act 5, Session Laws of Hawaii 2019,  
9 is amended by amending section 3 to read as follows:

10 "SECTION 3. APPROPRIATIONS. The following sums, or so  
11 much thereof as may be sufficient to accomplish the purposes and  
12 programs designated herein, are hereby appropriated or  
13 authorized, as the case may be, from the means of financing  
14 specified to the expending agencies designated for the fiscal  
15 biennium beginning July 1, 2019, and ending June 30, 2021. The  
16 total expenditures and the number of positions in each fiscal  
17 year of the biennium shall not exceed the sums and the position

- 2 elsewhere in this Act or as provided by general law.

SECTION 4. This part amends Act 28, Session Laws of Hawaii 2019, and other appropriations and authorizations effective during fiscal biennium 2019-2021.

13 the remainder of the Act and each and every other provision  
14 thereof shall not be affected thereby. If any portion of a  
15 specific appropriation is held to be invalid for any reason, the  
16 remaining portion shall be expended to fulfill the objective of  
17 the appropriation to the extent possible.

18 SECTION 19. If manifest clerical, typographical, or other  
19 mechanical errors are found in this Act, the governor is hereby  
20 authorized to correct those errors.


1           SECTION 20. Nothing in this Act shall affect the validity
