# A BILL FOR AN ACT

RELATING TO THE 1924 HANAPEPE MASSACRE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that on September 9,
- 2 1924, there occurred a tragic event that has come to be known as
- 3 the Hanapepe Massacre. The massacre involved the killing of
- 4 sixteen sugar plantation workers of Filipino descent in
- 5 Hanapepe, Kauai. The workers are said to have been shot and
- 6 killed by deputy sheriffs in the context of an ongoing labor
- 7 strike. It appears that no law enforcement officers connected
- 8 to the incident were investigated or charged with criminal
- 9 offenses.
- 10 The legislature also finds that according to an oral
- 11 history project published by the university of Hawaii at Manoa's
- 12 ethnic studies program in 1979, newspapers of the day carried
- 13 stories of the event sympathetic to the perspective of
- 14 plantation managers and owners. The strikers were characterized
- 15 as malcontents led by self-serving outside agitators who would
- 16 use whatever means necessary, including threats and violence, to
- 17 accomplish their ends. The massacre was blamed entirely on the

- 1 strikers, some of whom were imprisoned or deported. Further, a
- 2 2010 article in Honolulu Magazine reported that in response to
- 3 the deaths of plantation workers and law enforcement officers,
- 4 the Hawaiian Sugar Planters' Association "gave each of the four
- 5 sheriffs' families \$500 (\$6,300 in 2009 dollars), while the
- 6 families of the 16 strikers had to split about \$75 (\$947 in 2009
- 7 dollars), barely \$5 per dead striker."
- 8 The legislature further finds that a grave injustice was
- 9 committed in 1924, and that the hard work and sacrifices of the
- 10 slaughtered Filipino sugar plantation workers, and the
- 11 contributions of Kauai sugar plantation laborers as a whole,
- 12 should be memorialized in permanent monuments and displays
- 13 throughout the island of Kauai. Moreover, this forgotten story
- 14 and suppressed history about Hawaii's sugar plantation labor
- 15 movement contains many valuable lessons relevant to modern times
- 16 about the significance of cultural clashes, the powerful versus
- 17 the powerless, and the fear and intimidation that ensued.
- 18 Homage should be paid to the sugar plantation workers who
- 19 struggled for dignity and self-determination. These workers
- 20 organized and participated in labor strikes, in the face of
- 21 manipulation by those in power, in order to gain a voice for

- 1 themselves and other immigrant laborers. Therefore, it is
- 2 critical that the State take the lead in bringing awareness
- 3 about the 1924 Hanapepe Massacre as its one hundredth
- 4 anniversary in 2024 approaches. This educational effort may be
- 5 accomplished by using film and interactive media that brings the
- 6 relevance of past events into sharper focus.
- 7 The purpose of this Act is to:
- 8 (1) Require the state foundation on culture and the arts
  9 to erect monuments and displays on Kauai, and support
  10 the production of a documentary film, creation of a
  11 traveling exhibition and "talk story" event, and
  12 publication of a compendium in accordance with this
- 13 Act; and
- 14 (2) Appropriate funds for this purpose.
- 15 SECTION 2. (a) The state foundation on culture and the
- 16 arts shall erect multiple, life-size, permanent monuments at
- 17 appropriate locations throughout the island of Kauai to
- 18 memorialize the hard work and sacrifices of the 1924 Hanapepe
- 19 Massacre victims and the contributions of Kauai sugar plantation
- 20 laborers as a whole.

- 2 the Lihue Airport consisting of plaques or photographs depicting
- 3 the history of events leading up to, and culminating in, the
- 4 1924 Hanapepe Massacre.
- 5 (c) The foundation shall arrange and provide support for
- 6 the following activities:
- 7 (1) Production of a thirty-minute documentary film showing
- 8 the events that led up to the tragic massacre on
- 9 September 9, 1924, in Hanapepe, Kauai;
- 10 (2) Creation of an island-wide traveling exhibition and
- 11 "talk story" event depicting the importance of sugar
- plantation laborers in the State's history; and
- 13 (3) Publication of a comprehensive compendium on the 1924
- 14 Hanapepe Massacre that is readily accessible to the
- general public and that includes the history of events
- depicted in the documentary film and commentary by
- today's historians and scholars.
- 18 (d) The foundation's members and staff may consult with
- 19 other persons, organizations, or stakeholders as necessary to
- 20 determine appropriate locations and designs for the monuments
- 21 and determine appropriate content for the Lihue Airport display,

- 1 documentary film, traveling exhibition and "talk story" event,
- 2 and compendium.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2020-2021 for the
- 6 design, construction, and placement of monuments and displays on
- 7 Kauai in accordance with this Act.
- 8 The sum appropriated shall be expended by the department of
- 9 accounting and general services for the purposes of this Act.
- 10 SECTION 4. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$450,000 or so much
- 12 thereof as may be necessary for fiscal year 2020-2021 for the
- 13 production of a documentary film, creation of a traveling
- 14 exhibition and "talk story" event, and publication of a
- 15 compendium in accordance with this Act.
- 16 The sum appropriated shall be expended by the department of
- 17 accounting and general services for the purposes of this Act.
- 18 SECTION 4. This Act shall take effect on July 1, 2020.
