# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the moneys in the
- 2 treasury received from federal funds the sum of \$70,552 or so
- 3 much thereof as may be necessary for fiscal year 2020-2021 for
- 4 homeless services (HMS224) for increased expenditures levels for
- 5 federal funds.
- 6 SECTION 2. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$58,848 or so much
- 8 thereof as may be necessary for fiscal year 2020-2021 for child
- 9 protective services (HMS301) to establish two full-time
- 10 equivalent (2.0 FTE) permanent positions to support the East
- 11 Hawaii child welfare services section pilot project.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$570,000 or so much
- 14 thereof as may be necessary for fiscal year 2020-2021 for
- 15 general support for self-sufficiency services (HMS903) to
- 16 increase the federal ceiling for homeless shelter after-care
- 17 services.

- 1 SECTION 4. There is appropriated out of the moneys in the
- 2 treasury received from federal funds the sum of \$1,330,000 or so
- 3 much thereof as may be necessary for fiscal year 2020-2021 for
- 4 general support for self-sufficiency services (HMS903) to
- 5 increase the federal ceiling for homeless shelter after-care
- 6 services.
- 7 SECTION 5. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$350,000 or so much
- 9 thereof as may be necessary for fiscal year 2020-2021 for
- 10 homeless services (HMS224) for the state homeless database and
- 11 maintenance.
- 12 SECTION 6. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$5,000,000 or so much
- 14 thereof as may be necessary for fiscal year 2020-2021 for
- 15 homeless services (HMS224) for stored property and debris
- 16 removal services for state lands, and transportation to and from
- 17 the department of health's short-term stabilization bed
- 18 facilities.
- 19 SECTION 7. The sums appropriated shall be expended by the
- 20 department of human services for the purposes of this Act.

- 1 SECTION 8. If any provision of this Act, or the
- 2 application thereof to any person or circumstance, is held
- 3 invalid, the invalidity does not affect other provisions or
- 4 applications of the Act that can be given effect without the
- 5 invalid provision or application, and to this end the provisions
- 6 of this Act are severable.
- 7 SECTION 9. If manifest clerical, typographical, or other
- 8 mechanical errors are found in this Act, the governor may
- 9 correct the errors.
- 10 SECTION 10. This Act shall take effect on December 31,
- **11** 2059.
