## A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the moneys in the 2 treasury received from federal funds the sum of \$ or 3 so much thereof as may be necessary for fiscal year 2020-2021 4 for homeless services (HMS224) for increased expenditures levels 5 for federal funds. 6 SECTION 2. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ 8 much thereof as may be necessary for fiscal year 2020-2021 for 9 child protective services (HMS301) to establish two full-time 10 equivalent (2.0 FTE) permanent positions to support the east 11 Hawaii child welfare services section pilot project. 12 There is appropriated out of the general SECTION 3. 13 revenues of the State of Hawaii the sum of \$ or so 14 much thereof as may be necessary for fiscal year 2020-2021 for 15 general support for self-sufficiency services (HMS903) to increase the federal ceiling for homeless shelter after-care 16 17 services.

SECTION 4. There is appropriated out of the moneys in the 1 treasury received from federal funds the sum of \$ 2 so much thereof as may be necessary for fiscal year 2020-2021 3 for general support for self-sufficiency services (HMS903) to 4 5 increase the federal ceiling for homeless shelter after-care 6 services. 7 SECTION 5. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 8 9 much thereof as may be necessary for fiscal year 2020-2021 for 10 homeless services (HMS224) for the state homeless database and 11 maintenance. 12 SECTION 6. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$5,000,000 or so much 14 thereof as may be necessary for fiscal year 2020-2021 for 15 homeless services (HMS224) for stored property and debris 16 removal services for state lands, and transportation for homeless individuals to short-term stabilization bed facilities, 17 18 shelter, housing or appropriate treatment options; provided 19 that, with the governor's approval, the funds may be transferred 20 to other departments as needed to facilitate stored property, 21 debris removal, and transportation activities.

- 1 SECTION 7. The sums appropriated shall be expended by the
- 2 department of human services for the purposes of this Act.
- 3 SECTION 8. If any provision of this Act, or the
- 4 application thereof to any person or circumstance, is held
- 5 invalid, the invalidity does not affect other provisions or
- 6 applications of the Act that can be given effect without the
- 7 invalid provision or application, and to this end the provisions
- 8 of this Act are severable.
- 9 SECTION 9. If manifest clerical, typographical, or other
- 10 mechanical errors are found in this Act, the governor may
- 11 correct the errors.
- 12 SECTION 10. This Act shall take effect on December 31,
