A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE STATE ARCHIVES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the original state

2 archives building, known as the Kanaina Building, was built in

3 1905 on the Iolani Palace grounds within the Hawaii capital

4 historic district to house the public archives of Hawaii. After

5 many years of collecting and acquiring into the public archives

6 the most important records and artifacts of the governments of

Hawaii from the Hawaiian kingdom through statehood, the state

archives eventually outgrew the Kanaina Building and in 1952, a

new building adjacent to the Kanaina Building was constructed as

10 the new home of the state archives and named after Kekauluohi.

11 The legislature further finds that there exists a need to

12 promote citizen engagement in the documentary and tangible

13 artifact heritage of the government, provide greater education

14 of the history of Hawaii's governments and its people, and

15 assist the people of Hawaii in connecting with their personal

16 history as well as the history of Hawaii, in order to better

- 1 fulfill the role of the state archives as the keeper of the
- 2 public memory.
- 3 There also exists a need to have dedicated exhibition space
- 4 to highlight the many historic records and artifacts preserved
- 5 in the public archives that document the vibrant and diverse
- 6 history of Hawaii, its public institutions, and its people.
- 7 An additional challenge is presented when aging,
- 8 underrepresented, and marginalized segments of the community
- 9 seek to donate important historical documents and artifacts to
- 10 the state archives, but a lack of storage space in the current
- 11 state archives building requires the state archivist to be very
- 12 selective in accepting donations.
- 13 The legislature further finds that the Hawaii capital
- 14 historic district has been the center of Hawaii's government for
- 15 more than one hundred fifty years, now consists of twenty
- 16 buildings and structures, and was added to the National Registry
- 17 of Historic Places on December 1, 1978. The buildings and
- 18 structures within the Hawaii capital historic district have
- 19 distinct architectural styles, ranging from nineteenth century
- 20 adaptations of New England homes to the Italianate renaissance
- 21 revival and Neoclassic edifices of the Hawaiian monarchy. The

1 current state archives building does not fit architecturally 2 with the other buildings of the Hawaii capital historic district 3 and is outdated in function with electrical and elevator problems requiring expensive repair, along with a lack of stable 4 5 backup power, which puts the secure storage of the records at 6 risk. 7 The purpose of this Act is to provide funding for the development of a master plan to address the current and future 8 9 facilities needs of the state archives. 10 SECTION 2. The director of finance is authorized to issue 11 general obligation bonds in the sum of \$ or so much 12 thereof as may be necessary and the same sum or so much thereof 13 as may be necessary is appropriated for fiscal year 2020-2021 14 for the purpose of financing capital improvement projects as 15 follows: State Archives, Oahu 16 17 Plans for the development of a state archives master plan to 18 19 include expansion and creation of 20 new collections processing and
