### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the popularity of

2 Hawaii-made sea salt products is on the rise. Sea salt products

colored with Hawaiian charcoal, volcanic clay, and other natural

4 ingredients help to promote the State's brand.

5 The legislature further finds that addressing the federal

6 Food and Drug Administration's industry guidance regarding the

7 use of color additives in sea salt products should be a state

8 priority. This guidance indicates that sea salt manufacturers

9 that intend to use color additives not currently approved for

food use should first obtain approval through the federal Food

and Drug Administration's color additive petition process.

12 The purpose of this Act is to ensure the continued

viability of the State's sea salt manufacturing industry by

appropriating funds to provide education and support to local

15 businesses regarding the federal Food and Drug Administration's

16 industry guidance on colored sea salt.

- 1 SECTION 2. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2020-2021 to
- 4 provide education and support to businesses in the State
- 5 regarding the federal Food and Drug Administration's industry
- 6 quidance on colored sea salt.
- 7 The sum appropriated shall be expended by the department of
- 8 business, economic development, and tourism for the purposes of
- 9 this Act.
- 10 SECTION 3. No sum appropriated pursuant to this Act shall
- 11 be released unless private industry businesses collectively
- 12 contribute fifty per cent of the cost to conduct and submit to
- 13 the federal Food and Drug Administration any research, studies,
- 14 or analysis required to obtain federal Food and Drug
- 15 Administration approval of color additives used in Hawaii sea
- 16 salt.
- 17 SECTION 4. This Act shall take effect on July 1, 2112.

#### Description:

Appropriates funds to the Department of Business, Economic Development, and Tourism to provide education and support to local businesses regarding the federal Food and Drug Administration's industry guidance on colored sea salt. Requires Hawaii sea salt industries to collectively pay fifty per cent of the cost to conduct and submit to the federal Food and Drug Administration any research, studies, or analysis required for federal Food and Drug Administration approval of color additives used in Hawaii sea salt. Takes effect on 7/1/2112. (HD1)
