### A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the GoFarm Hawaii 2 program is critical to growing, creating, and commercializing 3 local farms that are capable of meeting Hawaii's food 4 sustainability goals. Currently, approximately eighty-five per 5 cent of the State's food is imported. This leaves the State 6 vulnerable to shipping disruptions and natural disasters. The 7 Hawaii emergency management agency estimates that, in the event 8 of port closures, food supplies would be exhausted in five to 9 seven days.

10 The food import industry also represents billions of 11 dollars each year that are leaving the State's economy. In 12 2014, local consumers spent approximately \$4,100,000,000 on 13 food. Approximately eighty-five per cent, or \$3,500,000,000 of 14 this was spent on imports. In contrast, only twelve per cent of 15 farms in the State make more than \$50,000 annually, and only 16 seven per cent reach more than \$100,000 in annual sales.

1 The GoFarm Hawaii program was developed by the university 2 of Hawaii college of tropical agriculture and human resources to 3 assist local farmers in growing and commercializing their 4 production. In 2019, the program provided business consulting, 5 training, and technical assistance to more than three hundred 6 seventy-five existing and aspiring farmers. GoFarm Hawaii also 7 helped more than sixty farmers apply for loans, leases, and 8 grants and to develop business plans and value-added products. 9 GoFarm Hawaii has also established beginning training 10 programs to assist new commercial farmers: two programs on the 11 island of Oahu and one each on the islands of Maui, Kauai, and 12 Hawaii. The certificate-based program includes education and 13 mentoring in agricultural production and business. In the last 14 three years, more than one hundred thirty students have 15 graduated from the beginning farmer training program. Of these, 16 almost fifty per cent started new farm businesses and fourteen 17 per cent found employment with existing operations in the 18 agricultural industry. The courses have been highly successful, 19 and the demand for enrollment often exceeds availability. In 20 2019, seventy-two aspiring farmers applied for twenty-four Oahu-21 based openings.

1 The legislature finds that funding for the GoFarm Hawaii 2 program comes exclusively from government and private grants. 3 To manage the program at existing levels, operating costs for 4 fiscal year 2021 are estimated at \$1,400,000, with \$400,000 of 5 that amount anticipated to be received from private grants. 6 Accordingly, the purpose of this Act is to: 7 (1) Appropriate funds for the GoFarm Hawaii program to 8 provide business consulting, technical assistance, and 9 beginner farmer training on at least four islands; and 10 Require the GoFarm Hawaii program to provide the (2) 11 chairperson of the board of agriculture with reports 12 on the program's annual goals, outputs, and outcomes. 13 SECTION 2. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2020-2021 for 16 the GoFarm Hawaii program to provide business consulting, 17 technical assistance, and beginning farmer training on at least 18 four islands.

19 The sum appropriated shall be expended by the university of20 Hawaii for the purposes of this Act.
