A BILL FOR AN ACT

RELATING TO AGRICULTURAL LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Act 90, Session Laws of Hawaii 2003, was		
enacted to authorize the transfer of certain non-agricultural		
park lands from the department of land and natural resources to	0	
the department of agriculture. The legislature finds that many	У	
lessees of large acreages of land, primarily farmers and

- 16 existing non-agricultural park lands transferred by this Act and
- 17 related facilities shall be transferred from the department of
- 18 land and natural resources to the department of agriculture.
- 19 (c) Lands transferred pursuant to this Act shall be:

1	(1)	Included in and subject to the requirements of the
2		program established pursuant to section 166E-3(b),
3		Hawaii Revised Statutes; and
4	(2)	Subject to section 166E-3(c), Hawaii Revised Statutes.
5	(d)	The department of land and natural resources and
6	departmen	t of agriculture shall jointly submit reports to the
7	legislatu	re no later than twenty days prior to the convening of
8	the regul	ar sessions of 2023 and 2024 on their efforts to comply
9	with this	Act. The reports shall include:
10	(1)	A list of all lands transferred pursuant to this Act;
11	(2)	A list of all lands in subsection (a) that have not
12		been transferred to the department of agriculture and
13		an explanation of why each of those lands have not
14		been transferred; and
15	(3)	Proposed legislation, if necessary.
16	SECT	ION 4. There is appropriated out of the non-
17	agricultu	ral park lands special fund established pursuant to
18	section 1	66E-7, Hawaii Revised Statutes, the sum of \$ or
19	so much t	hereof as may be necessary for fiscal year 2020-2021
20	for the p	urposes of section 3 of this Act.

- 1 The sum appropriated shall be expended by the department of
- 2 agriculture for the purposes of this Act; provided that upon
- 3 approval of the chairperson of the board of agriculture, funds
- 4 may be allocated to and expended by the department of land and
- 5 natural resources for the purposes of this Act.
- 6 SECTION 5. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect on July 1, 2020.
