A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. Chapter 353C, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"§353C- Mental health first aid training. (a) The
6	judiciary shall establish a mental health first aid training
7	program for personnel in the district and family courts whose
8	duties include proceedings for restraining or protective orders.
9	The program shall include a mandatory eight-hour interactive
10	training course triennially that teaches the skills necessary to
11	assist a person who is developing or has developed a mental
12	health disorder or mental health crisis, and to de-escalate
13	crisis situations as needed.
14	(b) The mandatory interactive training shall instruct
15	<pre>personnel to, at minimum:</pre>
16	(1) Identify signs of mental health crises, illness, and
17	instability;

Mental Health First Aid Training; Judiciary; Subsidy Program; DOH; Appropriation

Description:

Requires the judiciary to establish a mental health first aid training program that provides mandatory eight-hour sessions triennially for personnel in the district and family courts whose duties include proceedings for restraining or protective orders. Requires the director of health to establish an emergency examination and hospitalization subsidy program for the purpose of recruiting, retaining, and subsidizing the salaries of certain psychiatrists and psychologists.
