#### A BILL FOR AN ACT

RELATING TO A STATE POKER COMMISSION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to establish a poker
2	commission to oversee the licensing and operation of live poker
3	rooms in the State.
4	SECTION 2. The Hawaii Revised Statutes is amended by
5	adding a new chapter to be appropriately designated and to read
6	as follows:
7	"CHAPTER
8	POKER COMMISSION
9	<b>§ -1 Definitions.</b> As used in this chapter, unless the
10	context dictates otherwise:
11	"Commission" means the poker commission established under
12	this chapter.
13	"Licensee" means a person or entity that has been granted a
14	poker license by the poker commission to operate a live poker

1 "Live poker room" means a facility in which poker games are 2 played against other players at the facility and not against the 3 dealer or house. 4 S -2 Poker commission; establishment; powers and duties. 5 (a) There is established a poker commission, which shall be 6 attached to the department of business, economic development, and tourism for administrative purposes. The commission shall 7 8 comprise three commissioners, as follows: 9 The director of business, economic development, and (1) 10 tourism, or the director's designee, who shall serve 11 as the chair of the commission; 12 (2) The director of commerce and consumer affairs, or the 13 director's designee; and 14 The director of taxation, or the director's designee. (3) 15 The commission shall oversee the licensing and (b) 16 operation of specified poker activities in the State. The 17 commission may hire staff such as an executive director, 18 investigators, and clerical staff as necessary to carry out its 19 duties.

20 (c) The powers and duties of the commission shall be as21 follows:



1 (1) Review applications and award poker licenses for the 2 operation of live poker rooms; provided that not more 3 than one live poker room per county shall be 4 authorized to operate at any given time; 5 Establish, and ensure compliance with, terms and (2) 6 conditions for maintaining a valid poker license, 7 including safety and consumer protection requirements 8 and timely payment of applicable fees and taxes; and Adopt rules as necessary, pursuant to chapter 91, to 9 (3) 10 effectuate the purposes of this chapter. 11 -3 Authorized poker activities. The commission shall S 12 authorize and regulate poker, which shall be played only in live 13 poker rooms overseen by the commission. 14 -4 Qualifications for licensure. (a) Each applicant S 15 for a poker license shall include both an individual applicant 16 and an applying entity. 17 The application submitted shall be on a form approved (b) 18 by the commission and shall include supporting documentation to 19 establish the following: 20 (1) That the individual applicant:



1		(A)	Has been a legal resident of the State for not
2			less than five years preceding the date of
3			application;
4		(B)	Is not less than twenty-one years of age; and
5		(C)	Has had no felony convictions; and
6	(2)	That	the applying entity:
7		(A)	Has been organized under the laws of the State;
8		(B)	Has a Hawaii tax identification number;
9		(C)	Has a department of commerce and consumer affairs
10			business registration division number and suffix;
11		(D)	Has a federal employer identification number;
12		(E)	Is wholly held by Hawaii legal residents or
13			entities wholly controlled by Hawaii legal
14			residents who have been Hawaii legal residents
15			for not less than five years immediately
16			preceding the date the application was submitted;
17		(F)	Has financial resources under its control of not
18			less than \$1,000,000 for each poker license
19			applied for, in the form of bank statements or
20			escrow accounts, and that the financial resources
21			have been under the control of the applying



1 entity for not less than ninety days immediately 2 preceding the date the application was submitted; 3 and 4 Is composed of principals or members, each of (G) 5 whom has no felony convictions. 6 (C) A poker license shall not be sold or otherwise 7 transferred from one person to another person; provided that an 8 individual or entity that holds a poker license may take on 9 partners or additional owners, subject to the commission's 10 approval. 11 S -5 Fees. (a) Each application for a poker license 12 shall be accompanied by payment of an application fee, as set by 13 the commission; provided that eighty per cent of the fee shall 14 be refunded by the commission if the application is denied. 15 (b) Upon approval of an application, each approved 16 licensee shall pay a one-time licensing fee, as set by the

17 commission.

18 (c) All fees collected by the commission under this
19 chapter shall be deposited into the poker regulation special
20 fund established pursuant to section -8.

4 (c) A revocation order may include language that upon the
5 revocation order becoming final, all poker equipment and related
6 supplies shall be forfeited to the State.

7 (d) All proceedings for denial, suspension, fine, or
8 revocation of a license on any ground specified in this section
9 shall be conducted pursuant to chapter 91, including the right
10 to judicial review.

11 § -8 Poker regulation special fund. (a) There is
12 established in the state treasury the poker regulation special
13 fund, into which shall be deposited:

14 (1) All revenues from the operations of the poker
15 commission, including fees and fines collected; and
16 (2) Appropriations made by the legislature to the fund.
17 (b) Moneys in the poker regulation special fund shall be
18 used for the following purposes:

19 (1) Enforcement operations of the poker commission; and
20 (2) Public outreach and education efforts of the
21 commission."

1 SECTION 3. Section 712-1220, Hawaii Revised Statutes, is 2 amended by amending the definitions of "contest of chance" and 3 "gambling" to read as follows: 4 "Contest of chance" means any contest, game, gaming 5 scheme, or gaming device in which the outcome depends in a 6 material degree upon an element of chance, notwithstanding that 7 skill of the contestants may also be a factor therein [-], but 8 does not include poker played at a live poker room licensed 9 pursuant to chapter . 10 "Gambling"[. A] occurs when a person engages in gambling 11 if [he] the person stakes or risks something of value upon the 12 outcome of a contest of chance or a future contingent event not 13 under [his] the person's control or influence, upon an agreement 14 or understanding that [he] the person or someone else will 15 receive something of value in the event of a certain outcome. 16 Gambling does not include [bona]: 17 (1) Poker, when played at a live poker room licensed 18 pursuant to chapter ; or

19 (2) Bona fide business transactions valid under the law of
 20 contracts, including but not limited to contracts for
 21 the purchase or sale at a future date of securities or

1 commodities, and agreements to compensate for loss 2 caused by the happening of chance, including but not 3 limited to contracts of indemnity or guaranty and 4 life, health, or accident insurance." 5 SECTION 4. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$ or so 7 much thereof as may be necessary for fiscal year 2020-2021 for 8 the establishment and operating expenses of the poker 9 commission, including the acquisition of office space, furniture 10 and equipment, and office supplies, and the training of 11 commissioners. 12 The sum appropriated shall be expended by the department of 13 business, economic development, and tourism for the purposes of 14 this Act. 15 SECTION 5. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so 17 much thereof as may be necessary for fiscal year 2020-2021 for 18 the establishment of full-time equivalent ( .0 FTE) staff 19 positions for the poker commission.

The sum appropriated shall be expended by the department of
 business, economic development, and tourism for the purposes of
 this Act.

4 SECTION 6. This Act does not affect rights and duties that 5 matured, penalties that were incurred, and proceedings that were 6 begun before its effective date.

7 SECTION 7. Statutory material to be repealed is bracketed8 and stricken. New statutory material is underscored.

9 SECTION 8. This Act shall take effect on July 1, 2020.
