BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. (a) There is established within the department
 of transportation a two-year autonomous vehicles testing pilot
 program.

4 (b) An autonomous vehicle may be tested on any public road
5 in the State under the jurisdiction of the department that has a
6 publicly posted speed limit of thirty-five miles per hour or
7 less; provided that a conventional human driver shall remain
8 physically present in the vehicle at all times in case the
9 conventional human driver needs to intervene, supervise, or
10 prevent a collision or other issues during testing.

(c) The department may adopt rules pursuant to chapter 91,
Hawaii Revised Statutes, regarding the testing of autonomous
vehicles.

14 (d) The department shall determine which entities shall be 15 permitted to engage in the testing of autonomous vehicles in the 16 State.

1 "Autonomous vehicle" means an automated-driving-systemequipped vehicle capable of performing all aspects of the 2 3 dynamic driving task within its operational design domain, if 4 any, including achieving a minimal risk condition, without any 5 intervention or supervision by a conventional human driver. 6 "Conventional human driver" means a person who manually 7 exercises in-vehicle braking, accelerating, steering, and 8 transmission gear selection input devices in order to operate a 9 motor vehicle. 10 SECTION 2. (a) No later than twenty days prior to the 11 convening of the regular session of 2023, the department of 12 transportation shall submit to the legislature a report of its findings and recommendations, including any proposed 13 14 legislation, regarding the autonomous vehicles testing pilot 15 program. 16 (b) The report shall include: A recommendation of whether autonomous vehicles are 17 (1)18 ready to be fully deployed in Hawaii; and Issues surrounding the feasibility and safety of the 19 (2) 20 operation of autonomous vehicles on Hawaii's roads, as

1 well as other matters deemed relevant by the 2 department of transportation. SECTION 3. There is appropriated out of the general 3 revenues of the State of Hawaii the sum of \$ 4 or so much thereof as may be necessary for fiscal year 2020-2021 for 5 the autonomous vehicles testing pilot program. 6 The sum appropriated shall be expended by the department of 7 8 transportation for the purposes of this Act. 9 SECTION 4. This Act shall take effect on July 1, 2050; 10 provided that section 1 of this Act shall be repealed on 11 June 30, 2022.
