### A BILL FOR AN ACT

RELATING TO GROUND TRANSPORTATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the use of fossil 2 fuels is the State's primary contributor to greenhouse gas 3 emissions in the atmosphere. The legislature further finds 4 that, under the Hawaii Clean Energy Initiative, the State has a 5 ground transportation goal of reducing the consumption of 6 petroleum in ground transportation by approximately three 7 hundred eighty-five million gallons per year. Additionally, the 8 mayors of all counties have established a clean ground 9 transportation goal of being one hundred per cent clean by 2045. 10 The purpose of this Act is to accelerate the transition of 11 the State's ground transportation to clean transportation 12 alternatives by prohibiting the sale or offer for sale of new 13 motor vehicles that are solely powered by fossil fuels and

14 designed for personal, family, or household use.

15 SECTION 2. Chapter 437, Hawaii Revised Statutes, is 16 amended by adding a new section to part I to be appropriately 17 designated and to read as follows:

17	matured, penalties that were incurred, and proceedings that were	
18	begun before its effective date.
