#### A BILL FOR AN ACT

RELATING TO WATER RATES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 269, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "<u>\$269-</u> <u>Water rates.</u> The public utilities commission
- 5 may fix and adjust rates and charges for the furnishing of water
- 6 and for water service; provided that the public utilities
- 7 commission may establish variable rates among the several
- 8 districts of the county of Hawaii or among the areas served by
- 9 the individual water systems within the county of Hawaii, for
- 10 the purpose of establishing charges as closely as possible to
- 11 the necessary amount required for the maintenance and operation
- 12 of the individual water systems; provided further that no rates
- 13 or charges shall be fixed or adjusted prior to the holding of a
- 14 public hearing by the public utilities commission, public notice
- of which shall be given not less than twenty days before the
- 16 date of the public hearing and the notice shall set forth the
- 17 time, place of the hearing, and the proposed rates and charges

- 1 to be considered. The public utilities commission may collect
- 2 and enforce the collection of the rates and charges by
- 3 appropriate means, including the discontinuance of service to
- 4 delinquent consumers, or commencement of civil action in the
- 5 name of the board; and adjust and settle all complaints, claims,
- 6 and accounts of consumers or the public. All water furnished to
- 7 the State or any department thereof or to the county or any
- 8 department thereof shall be charged to the respective
- 9 departments and shall be payable to the public utilities
- 10 commission by the respective departments at the rates and times
- 11 established by the public utilities commission, and, upon
- 12 failure of the departments to make payment when payment is due,
- 13 then the auditor of the county and the state comptroller shall
- 14 pay from the account of the department or departments all
- 15 delinquencies as certified by the chairperson of the public
- 16 utilities commission."
- 17 SECTION 2. Section 54-15, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "§54-15 Powers and duties of board. [The] Except as
- 20 provided in section 269- , the board of water supply shall
- 21 manage, control, and operate the waterworks of the county and



- 1 all property thereof, for the purpose of supplying water to the
- 2 public in the county, and shall collect, receive, expend, and
- 3 account for all sums of money derived from the operation thereof
- 4 and all other moneys provided for the use or benefit of the
- 5 waterworks and all property used for or held in connection
- 6 therewith. A board shall obtain approval of the public
- 7 utilities commission pursuant to section 269- prior to
- 8 implementing any rate adjustment."
- 9 SECTION 3. Section 54-51, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "§54-51 Board of water supply. There shall be a board of
- 12 water supply of the county of Hawaii, to consist of nine
- 13 members, of whom eight shall be appointive members and be
- 14 appointed as hereinafter provided, and of whom the ninth member
- 15 shall always be the person who for the time being shall be the
- 16 legal incumbent of the office of the chief engineer of the
- 17 department of public works of the county. [The] Except as
- 18 provided in section 269- , the board shall manage, control,
- 19 and operate the water systems and properties of the county, for
- 20 the supplying of water to the public within the several
- 21 districts of the county, and collect, receive, expend, and

- 1 account for all sums of money derived from the operation
- 2 thereof, and all other moneys provided for the use or benefit of
- 3 each or all of the water systems as in this part provided. The
- 4 board shall obtain approval of the public utilities commission
- 5 pursuant to section 269- prior to implementing any rate
- 6 adjustment."
- 7 SECTION 4. Section 54-26, Hawaii Revised Statutes, is
- 8 repealed.
- 9 ["\$54-26 Rates. The board of water supply may fix and
- 10 adjust rates and charges for the furnishing of water and for
- 11 water service; provided no rates or charges shall be fixed or
- 12 adjusted prior to the holding by the board of a public hearing,
- 13 public notice of which shall be given not less than twenty days
- 14 before the date of the public hearing and the notice shall set
- 15 forth the time, place of the hearing, and the proposed rates and
- 16 charges to be considered thereat. The board may collect and by
- 17 appropriate means, including the discontinuance of service to
- 18 delinquent consumers, or commencement of civil action in the
- 19 name of the board, enforce the collection of the rates and
- 20 charges; and adjust and settle all complaints, claims, and
- 21 accounts of consumers or the public. All water furnished to the

county or any department thereof or to the State or any 2 department thereof shall be charged to the respective 3 departments and shall be payable to the board by the respective 4 departments at the rates and times established by the board, 5 and, upon failure of the departments to make payment when 6 payment is due, then the auditor of the county and the 7 comptroller of the department of accounting and general services 8 of the State shall pay from the account of the department or 9 departments all delinquencies as certified by the chairperson of 10 the board." 1 11 SECTION 5. Section 54-63, Hawaii Revised Statutes, is 12 repealed. 13 ["\$54-63 Rates. The board of water supply may fix and 14 adjust rates and charges for the furnishing of water and for 15 water services so that the revenues derived therefrom shall be 16 sufficient to make the waterworks and water systems self-17 supporting and to meet all expenditures authorized by this part; 18 the board may establish variable rates among the several 19 districts of the county, or among the areas served by the 20 individual water systems within the county, for the purpose of 21 establishing charges as closely as possible to the necessary

- 1 amount required for the maintenance and operation of the
- 2 particular individual water systems; provided no rates and
- 3 charges shall be fixed or adjusted prior to the holding by the
- 4 board of a public hearing, public notice of which shall have
- 5 been given not less than twenty days before the date set for the
- 6 hearing. The notice shall state the time and place for the
- 7 hearing and the proposed rates and charges to be considered
- 8 thereat. The time within which the notice shall be given shall
- 9 be computed by including the first day (the day of notice) and
- 10 excluding the last day."]
- 11 SECTION 6. This Act does not affect rights and duties that
- 12 matured, penalties that were incurred, and proceedings that were
- 13 begun before its effective date.
- 14 SECTION 7. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 8. This Act shall take effect upon its approval.
