# A BILL FOR AN ACT

RELATING TO THE ELIGIBILITY OF FIREFIGHTERS, EMERGENCY MEDICAL SERVICES PERSONNEL, AND LAW ENFORCEMENT OFFICERS TO RECEIVE WORKERS' COMPENSATION BENEFITS FOR POST-TRAUMATIC STRESS DISORDER.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Chapter 386, Hawaii Revised Statutes, is

2 amended by adding a new section to part I to be appropriately

3 designated and to read as follows:

4 "§386- Firefighters; emergency medical service

5 personnel; law enforcement officers; post-traumatic stress

6 disorder. (a) Any firefighter, emergency medical service

7 personnel, or law enforcement officer diagnosed with post-

8 traumatic stress disorder by a licensed mental health

9 professional shall be presumed to have incurred the post-

10 traumatic stress disorder in the course of employment and the

11 injury shall be compensable; provided that the presumption may

12 be rebutted by a showing of proof by preponderance of the

13 evidence that the post-traumatic stress disorder was not

14 incurred in the course of employment.

2	meaning as in section 321-222.
3	"Firefighter" shall have the same meaning as in section
4	<u>587D-1.</u>
5	"Law enforcement officer" shall have the same meaning as in
6	section 701-118.
7	"Licensed mental health professional" means any of the
8	following:
9	(1) A person licensed as a psychologist pursuant to
10	chapter 465;
11	(2) A board certified, or board eligible, licensed
12	psychiatrist; or
13	(3) An advanced practice registered nurse licensed
14	pursuant to chapter 457 who holds an accredited
15	national certification in an advanced practice
16	registered nurse psychiatric specialization.
17	"Post-traumatic stress disorder" means a disorder that:
18	(1) Meets the diagnostic criteria for post-traumatic
19	stress disorder specified by the American Psychiatric
20	Association in the Diagnostic and Statistical Manual

## Report Title:

Workers' Compensation; PTSD; Firefighters; Emergency Medical Service Personnel; Law Enforcement Officers

Establishes a rebuttable presumption that any firefighter, emergency medical service personnel, or law enforcement officer diagnosed with post-traumatic stress disorder incurred that injury while in the course of employment for the purposes of receiving workers' compensation benefits.
