13	(4)	Dynastinae, commonly known as "rhinoceros beetles";

1 The legislature further finds that although the axis deer 2 population may be referred to as an invasive species, it also 3 significantly contributes to the subsistence hunting life style 4 and cultural practices of the residents of Maui. Accordingly, 5 available resources should be focused on the management of the 6 axis deer population to mitigate its negative environmental 7 impacts, rather than its complete extermination. 8 The purpose of this Act is to appropriate funds to 9 substantially reduce and eradicate the problem of invasive 10 species in the county of Maui; provided that the population of 11 axis deer shall be managed, rather than eradicated. 12 SECTION 2. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$ or so much 14 thereof as may be necessary for fiscal year 2019-2020 and the 15 same sum or so much thereof as may be necessary for fiscal year 16 2020-2021 for activities relating to the management of the axis 17 deer population and substantial reduction and eradication of 18 other invasive species in the county of Maui pursuant to this 19 Act.
