A BILL FOR AN ACT

RELATING TO CHARTER SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 302D-7, Hawaii Revised Statutes, is 2 amended to read as follows:

"§302D-7 Authorizer reporting. Every authorizer shall be required to submit to the board and the legislature an annual report [summarizing:] that includes:

- (1) The authorizer's strategic vision for chartering and progress toward achieving that vision;
- 8 (2) [The academic performance of all operating public 9 charter schools overseen by the authorizer, according 10 to the performance expectations for public charter 11 schools set forth in this chapter, including a 12 comparison of the performance of public charter school 13 students with public school students statewide; The 14 performance report for each public charter school it 15 oversees, in accordance with the performance framework 16 set forth in the charter contract and section 302D-16;
