### A BILL FOR AN ACT

RELATING TO THE DONATION OF FOOD.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 321, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§321- Promotion of food donation. In implementing
- 5 this chapter, registered sanitarians or food and drug inspectors
- 6 shall promote the recovery of food fit for human consumption
- 7 during their normal, routine inspections. Promotion shall
- 8 include but not be limited to newsletters, bulletins, and
- 9 handouts that inform food establishment operators about the
- 10 protections from civil and criminal liability when donating
- 11 <u>food.</u>"
- 12 SECTION 2. Chapter 328, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "§328- Food donation permitted. (a) A person or
- 16 gleaner engaged in the business of processing, distributing, or
- 17 selling a food product may donate, free of charge, a food



1 product that is in a condition that may be used as food for 2 human consumption to a charitable, religious, or nonprofit 3 organization or food bank within the State. 4 (b) A person, gleaner, or food facility may donate, free 5 of charge, food that is fit for human consumption: 6 (1) Directly to end recipients for consumption; or 7 (2) To a charitable, religious, or nonprofit organization 8 or food bank. 9 (c) A person, gleaner, or food facility that donates food 10 as permitted by this section shall not be subject to civil or 11 criminal liability for violation of any laws, regulations, or 12 ordinances regulating the labeling or packaging of the donated 13 food or, with respect to any other laws, regulations, or 14 ordinances, for a violation occurring after the time of the 15 donation. 16 (d) A person, gleaner, or food facility may donate 17 perishable or nonperishable food that is fit for human 18 consumption but has exceeded the labeled shelf life date 19 recommended by the manufacturer; provided that the person that 20 distributes the perishable food to the end recipient makes a

good faith evaluation that the food to be donated is wholesome.

1 (e) To assist in accomplishing the purposes of this section, the director may divert food products to organizations 2 or food banks operating pursuant to this section. 3 4 (f) For the purposes of this section: 5 "Charitable, religious, or nonprofit organization" shall 6 have the same meaning as in section 145D-1. 7 "Food bank" shall have the same meaning as in section 145D-8 1. 9 "Food facility" shall have the same meaning as in section 10 145D-1. 11 "Food product" means any fowl, seafood, animal, vegetable, 12 or other stuff, product, or article that is customary food fit 13 for human consumption, including prepared, canned, milk, dairy, 14 and farm products. 15 "Gleaner" shall have the same meaning as in section 145D-1. 16 "Person" shall have the same meaning as in section 145D-1." **17** SECTION 3. Section 145D-1, Hawaii Revised Statutes, is 18 amended to read as follows: 19 "§145D-1 Definitions. Whenever used in this chapter 20 unless the context otherwise requires:

"Charitable, religious, or nonprofit organization" means 1 2 any organization [which] that was organized and is operating in 3 the State for charitable or religious purposes or to promote 4 social welfare, which is exempt from income taxation under 5 chapter 235, and which distributes food [products] at no cost to 6 the needy [persons]. "Commercial food processing establishment" means any room, 7 8 building, or place or portion thereof, maintained, used, or 9 operated for the purpose of commercially storing, packaging, making, cooking, mixing, processing, bottling, canning, packing, 10 11 slaughtering, or otherwise preparing or handling food. 12 "Commercial food processing establishments" do not include 13 restaurants. 14 "Community care facility" means any facility, place, or 15 building that is maintained and operated by an individual, 16 organization, or agency for the purpose of providing supportive 17 and protective care to a disabled or aged person or providing 18 care to children, including but not limited to adult day care 19 centers, developmental disabilities domiciliary homes, and 20 developmentally disabled adult foster homes licensed by the 21 department of health and child care facilities, child caring

1	institutions, or resource family homes licensed, registered, or
2	regulated by the department of human services.
3	"Food bank" means a surplus food collection and
4	distribution system operated and established to assist in
5	bringing donated food to charitable, religious, or nonprofit
6	organizations and individuals for the purposes of reducing
7	hunger and supplying nutritional needs.
8	"Food facility" means an operation that stores, prepares,
9	packages, serves, vends, or otherwise provides food for human
10	consumption at the retail level, including but not limited to:
11	(1) An operation where food is consumed on or off the
12	premises, regardless of whether there is a charge for
13	the food; or
14	(2) Storage facilities for food-related utensils,
15	equipment, and materials.
16	"Food facility" includes permanent and nonpermanent facilities,
17	including but not limited to public and private school
18	cafeterias, licensed health care facilities, mobile food
19	facilities, vending machines, farmers' markets, farm stands,
20	mobile markets, fish markets, or catering operations. "Food
21	facility" does not include any of the following:

	(1)	A cooperative arrangement wherein no permanent
2		facilities are used for storing or handling food;
3	(2)	A private home when used for private, noncommercial
4		purposes;
5	(3)	A church, private club, or other nonprofit association
6		that gives or sells food to its members and guests,
7		and not to the general public, at an event that occurs
8		not more than three days in any ninety-day period;
9	(4)	A for-profit entity that gives or sells food at an
10		event that occurs not more than three days in a
11		ninety-day period for the benefit of a nonprofit
12		association, if the for-profit entity receives no
13		monetary benefit, other than that resulting from
14		recognition from participating in an event;
15	(5)	Premises set aside for wine tasting or by a beer
16		manufacturer, regardless of whether there is a charge
17		for the wine or beer tasting, if no other beverage,
18		except for bottles of wine or beer and prepackaged
19		nonpotentially hazardous beverages, is offered for
20		sale or for onsite consumption and no food, except for
21		crackers, pretzels, or prepackaged food that is not

1		potentially hazardous food is offered for sale or for
2		onsite consumption;
3	(6)	An outlet or location, including but not limited to
4		premises, operated by a producer, selling or offering
5		for sale only whole produce grown by the producer or
6		shell eggs, or both; provided that the sales are
7		conducted at an outlet or location controlled by the
8		<pre>producer;</pre>
9	(7)	A commercial food processing establishment;
10	(8)	A community care facility; or
11	(9)	A community food producer.
12	<u>"Gle</u>	aner" means a person who harvests for free distribution
13	to the ne	edy, or for donation to a charitable, religious, or
14	nonprofit	organization or food bank for ultimate distribution to
15	the needy	, an agricultural crop that has been donated by the
16	owner.	
17	[ <del>"Do</del>	nor" means any person, partnership, corporation,
18	company,	or association engaged in the farming, processing,
19	<del>distribut</del>	ion, wholesaling, or retailing of food products who
20	<del>donates s</del>	uch products, without remuneration, to a charitable,
21	religious	, or nonprofit organization.

"Food product" means any fowl, seafood, animal, vegetable, 1 2 or other stuff, product, or article which is customary food fit 3 for human consumption, including prepared, canned, milk, dairy, 4 and farm products, before or after the expiration date stamped 5 on the products, if any. 6 "Needy person" means any person who lacks adequate or 7 proper means of subsistence. 8 "Person" means an individual, school, corporation, 9 partnership, limited liability company, organization, 10 association, or governmental entity, including a retail food 11 establishment, retail grocer, wholesaler, hotel, motel, 12 manufacturer, restaurant, caterer, farmer, and nonprofit food 13 distributor or hospital. In the case of a corporation, 14 partnership, organization, association, or governmental entity, 15 the term "person" includes an officer, director, partner, 16 manager or managing member, deacon, trustee, council member, or **17** other elected or appointed individual responsible for the 18 governance of the entity. 19 "Producer" means a person or entity who produces shell eggs or edible plants by practice of the agricultural arts upon land 20 21 that the person or entity controls."

1	(b) The immunity from civil and criminal liability
2	provided by subsection (a) applies regardless of compliance with
3	any laws, regulations, or ordinances regulating:
4	(1) The labeling or packaging of food; or
5	(2) The storage or handling of the food by the donee after
6	the donation of the food.
7	(c) The exceptions to liability specified in subsection
8	(a) shall include the donation of perishable or nonperishable
9	food that is fit for human consumption but has exceeded the
10	labeled shelf life date recommended by the manufacturer;
11	provided that the person that distributes the perishable food to
12	the end recipient makes a good faith evaluation that the food to
13	be donated is wholesome.
14	[ <del>(b)</del> ] <u>(d)</u> A charitable, religious, or nonprofit
15	organization [which] or food bank that, in good faith, receives
16	and distributes food[, apparently] without charge that is fit
17	for human consumption[, and distributes it to needy persons at
18	no charge, at the time the food was distributed shall not be
19	liable for any civil damages or criminal penalties resulting
20	from [the condition of the food unless] an injury [or], illness
21	[ <del>results from its</del> ], or death unless the injury, illness, or



- 1 <u>death is a direct result of the gross negligence, intentional</u>
- 2 <u>misconduct</u>, or wanton acts or omissions[-] of the organization.
- 3 [<del>(c)</del>] <u>(e)</u> This section shall not relieve any organization
- 4 from any other duty imposed upon them by law for the inspection
- 5 of donated food products or for any provisions regarding the
- 6 handling of such products.
- 7 (f) Nothing in this chapter shall be construed to limit
- 8 the ability of a person, gleaner, or food facility to donate
- 9 food."
- 10 SECTION 5. Section 145D-4, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- "[+] §145D-4[+] Labeling of donated food. Any charitable,
- 13 religious, or nonprofit organization [which] or food bank that
- 14 receives and distributes donated food pursuant to this chapter
- 15 shall affix a label upon such food or upon the individual
- 16 container or package of such food stating that the food is not
- 17 for resale and stating that it was fit for human consumption at
- 18 the date that it left control of the charitable, religious, or
- 19 nonprofit organization[-] or food bank."
- 20 SECTION 6. Section 663-10.6, Hawaii Revised Statutes, is
- 21 amended by amending subsections (a) and (b) to read as follows:



- 1 "(a) Any charitable or nonprofit organization that in good
- 2 faith provides shelter or proper means of subsistence to needy
- 3 persons as part of its bona fide and customary charitable
- 4 activities, rendered without remuneration or expectation of
- 5 remuneration, shall be exempt from civil liability for injuries
- 6 and damages resulting from the organization's acts or omissions
- 7 in providing [such] the shelter or subsistence, except for gross
- 8 negligence or wanton acts or omissions of the organization.
- 9 (b) Any [person] donor who donates goods, [food,]
- 10 materials, or services [to]:
- 11 (1) Directly to a needy person; or
- 12 (2) To a charitable or nonprofit organization described in
- subsection (a);
- 14 shall be exempt from civil liability for injuries and damages
- 15 resulting from the donation, except for gross negligence or
- 16 wanton acts or omissions."
- 17 SECTION 7. This Act does not affect rights and duties that
- 18 matured, penalties that were incurred, and proceedings that were
- 19 begun before its effective date.
- 20 SECTION 8. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.



SECTION 9. This Act shall take effect upon its approval.
