A BILL FOR AN ACT

RELATING TO THE KA IWI COAST.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the lands of the Ka
 Iwi coast are an invaluable natural asset for the people of
 Hawaii. Numerous community members and organizations have
 fought long and hard over many decades to protect and preserve
 this unspoiled area for future generations.

6 The legislature further finds that a growing interest in 7 this area of Oahu has brought a rapid increase in visitors to 8 the Ka Iwi coast, and without proper management the area will 9 inevitably become overrun by invasive species and commercial 10 interests or become subject to future development.

11 Collaboration between community organizations and 12 government agencies is necessary to address myriad issues, such 13 as managing human impacts, preventing invasive species, and 14 restoring the Wawamalu dune system.

15 The purpose of this Act is to protect and preserve the16 lands of the Ka Iwi coast in perpetuity by establishing the Ka

Iwi coast state park for the benefit of local residents and
 future generations.

3 SECTION 2. (a) Lands spanning Wawamalu to Makapuu, identified by tax map key numbers: a portion of (1)3-9-10:003 4 5 located makai of Kalanianaole highway and terminating at the 6 eastern access road ingress and egress for Sandy beach park 7 trending southerly to (1)3-9-12:002; a portion of (1)3-9-12:0028 located makai of Kalanianaole highway and makai of (1)3-9-10:003 9 starting at Kaiwi state scenic shoreline and terminating at 10 eastern access road ingress and egress for Sandy beach park trending southerly to the shoreline; and (1)3-9-15:020, shall be 11 12 transferred to the department of land and natural resources. 13 These lands and lands identified by tax map key numbers (1)3-9-14 11:002 and (1)3-9-11:007 located within the Kaiwi state scenic 15 shoreline, shall be designated as a state park under the name 16 "Ka Iwi coast state park", to be administered by the department 17 of land and natural resources.

(b) All land within or added to the Ka Iwi coast state
park shall be designated conservation land. Any land of
differing designation shall have its designation automatically
changed to conservation.

1 (c) Land in the Ka Iwi coast state park shall, in 2 perpetuity, be preserved primarily in its wild and natural 3 state. 4 (d) Any land subsequently added to the Ka Iwi coast state 5 park shall be subject to the provisions established in this 6 section. 7 This Act shall be exempt from the requirements of (e) 8 section 171-64.7, Hawaii Revised Statutes, and the boundary 9 amendment requirements of chapter 205, Hawaii Revised Statutes. 10 SECTION 3. The following positions are established within 11 the department of land and natural resources to support the 12 establishment and administration of the Ka Iwi coast state park: 13 One full-time equivalent (1.0 FTE) park caretaker III; (1)14 and 15 (2) One full-time equivalent (1.0 FTE) interpretive 16 specialist. 17 SECTION 4. There is appropriated out of the general 18 revenues of the State of Hawaii the sum of \$ or so 19 much thereof as may be necessary for fiscal year 2020-2021 for 20 the design, construction, planning, and establishment of the Ka
