

A BILL FOR AN ACT

RELATING TO OCCUPATIONAL HEALTH AND SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 396, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§396- Acute care hospitals; zero lift policy. (a)
- 5 Each general acute care hospital licensed under section 321-14.5
- 6 shall adopt a health care worker back injury prevention plan
- 7 under which a needs assessment shall be conducted in relation to
- 8 patient lifts. As part of the needs assessment, each hospital
- 9 subject to this section shall develop a lifting and transferring
- 10 process that identifies the patients who require the appropriate
- 11 use of lift teams and lifting devices and equipment.
- 12 (b) Each hospital subject to this section shall implement
- 13 a "zero lift policy" for all shifts for patients identified
- 14 pursuant to subsection (a) as requiring the use of lift teams
- 15 and lifting devices and equipment. Each general acute care
- 16 hospital subject to this section, as appropriate and consistent
- 17 with the needs assessment developed pursuant to subsection (a),

- 1 shall use lift teams and lifting devices and equipment. Each
- 2 general acute care hospital subject to this section shall
- 3 provide training to health care workers on the appropriate use
- 4 of the lifting devices and equipment. Training for these health
- 5 care workers shall include body mechanics and the use of lifting
- 6 devices to safely handle patients.
- 7 (c) Lift team members shall be given specialized training
- 8 and shall demonstrate proficiency in safe techniques for lifting
- 9 or transferring patients and the appropriate use of lifting or
- 10 transferring devices and equipment. Lift teams shall use
- 11 lifting devices and equipment when assisting health care workers
- 12 throughout the hospital to lift patients unless the use of
- 13 lifting devices and equipment is specifically contraindicated
- 14 for the patient's condition or medical status.
- (d) A health care worker who refuses to lift a patient due
- 16 to concerns about worker and patient safety and the lack of
- 17 trained lift team personnel or equipment shall not be the
- 18 subject of disciplinary action by the hospital or any of its
- 19 managers or employees that is based solely upon the refusal.
- 20 (e) Notwithstanding subsection (d), the hospital, its
- 21 managers, or it employees may discipline a health care worker

- 1 who refuses to lift a patient if the health care worker has been
- 2 trained on appropriate patient and equipment lifting procedures
- 3 and has appropriate, functional lifting devices and equipment
- 4 available to perform the requested lift.
- 5 (f) It is not the intent of this section to prescribe a
- 6 particular process for acute care hospitals subject to this
- 7 section.
- **8** (g) For the purposes of this section:
- 9 "Lifting and transferring process" means a system whereby
- 10 patients are identified based upon the potential risk of injury
- 11 to the health care worker if the worker would need to lift or
- 12 transfer that patient.
- "Lift team" means hospital employees specially trained to
- 14 handle patient lifts and transfers; provided that nothing in
- 15 this section shall preclude lift team members from performing
- 16 other duties as assigned during their shift.
- "Zero lift policy" means replacing manual lifting and
- 18 transferring of patients with powered patient transfer devices,
- 19 lifting devices, or lift teams, consistent with the needs
- 20 assessment developed by the hospital pursuant to subsection
- **21** (a)."



- 1 SECTION 2. This Act does not affect rights and duties that
- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
- 4 SECTION 3. New statutory material is underscored.
- 5 SECTION 4. This Act shall take effect upon its approval.
